# Department of Recreation and Parks Briefing Paper 5/23/2024 Open Session

**Issue:** Approval to Purchase - two parcels that are contiguous to Cape Horn Park

Background: Briefing/Decision

Two separate parcels owned by the estate of Judith Ann Leese Green became available to purchase in early 2023. Both parcels are adjacent to and contiguous to Cape Horn Park property.

For future expansion of the existing park property and to provide additional recreational opportunities to the citizens of Carroll County, the Department of Recreation and Parks requested permission to have both parcels appraised. The BCC directed both the Department of Recreation and Parks and the Department of Public Works to complete these appraisals. A Contract of Sale was entered into and title work was completed. The Notice of Intent to Purchase Land was also advertised on the county's website.

Since acquisition funding will be coming from Program Open Space (POS) two independent appraisals were completed. Parcel 49 is zoned Agricultural and Parcel 341 is zoned Commercial. The results are as follows:

Appraiser: Lipmann Frizzell and Mitchell Karen H Belinko Appraisals

Parcel 49: \$530,000 \$391,000 Parcel 341 \$590,000 \$1,024,000

The difference in the value of Parcel 49 is due to Manchester's Master Plan for a possible annex, resulting in a higher value for the ag land at \$25,000 per acre vs the almost \$14,500 per acre from the second appraiser.

In accordance with POS mandates, acquisition funding can be used to purchase future parkland using the lowest of the two appraisals or an average of the two. The average of the appraisals is \$1,267,500.

Carroll County currently has an available POS acquisition funding balance of \$1,875,090, which would cover the property purchase, as well as any incidental costs (appraisals, survey, title, etc.). The Department of Public Works has been in contact with the attorney of the Estate of Judith Green and has negotiated a final sales price of \$1,120,000 for both these parcels. Staff would like to move forward with settlement of these properties.

If the purchase is approved, a new capital project (Cape Horn Park Expansion) needs to be established and a budget transfer of \$1,120,000 from the (POS) Land Acquisition capital project needs to be approved through capital budget resolution C-24.05.

#### **Staff Recommended Motion:**

I move that the Board of County Commissioners authorize the Department of Recreation and Parks with assistance of the Department of Public Works to purchase both parcels, for a final sales price of \$1,120,000.

I move that the Board of County Commissioners establish a new capital project, Cape Horn Park Expansion, and approve capital budget resolution C-24.05.

# **Issue:**

Carroll County Infrastructure & Investments Fund Transfer

# **Background:**

The Department of Economic Development has an Infrastructure & Investments Fund to use for business expansion and relocation projects which increase the tax base and create and/or retain jobs. Constructing a business park from raw land is a lengthy process. It can take nearly two years from concept to final approval. Businesses that are looking to build are interested in sites that are shovel-ready i.e., a site that is prepared with all infrastructure already in place. To remain competitive in attracting businesses, it is critical for the County to have an inventory of finished sites to market.

Carroll County partners with the Industrial Development Authority (IDA), a quasi-public entity, to undertake industrial park development. Most recently, the IDA developed the North Carroll Business Park southern parcel which is now complete and being actively marketed. The IDA is currently evaluating two additional development parcels which will increase Carroll's inventory of industrial property. Planning for future growth and development is critical to Carroll's long-term economic viability and this funding transfer is an investment in that future viability.

# **EXECUTIVE SUMMARY:**

The Office of Procurement, in cooperation with the Bureau of Roads Operations, requests your approval to use Proshot Concrete, Inc. to pneumatically apply shotcrete to inverts on three (3) pipes nearest to 4570 N. Stone Road, Taneytown at a cost \$44,440.00. This cost includes mobilization, stream diversion, debris removal, traffic control, and invert paving. This service is being purchased via contract #IFB No. 22-243 which Harford County competitively bid.

This amount is within the approved budget and no additional funds should be necessary.

**Background:** The Department of Public Works (DPW) has evaluated the Structural Steel Plate (SSP) culverts with extremely deep corrugation at 4570 N. Stone Road, Taneytown and determined they have severely deteriorated and are in poor operating condition which has caused a hole to develop in the roadway, currently covered by a steel plate. These SSP's are elliptical pipes measuring 4' x 6' x 31' long.

A Maryland Department of the Environment (MDE) permit is required for this location and in process however, if possible, the work will be completed under emergency circumstances due to the existing hole in the roadway. The road will remain open to through traffic during the work activity. The estimated time to complete the work is 7 days.

The quote submitted by Proshot Concrete, Inc. is \$44,440.00. Proshot Concrete, Inc. has a term contract, which was competitively bid and awarded, in place with the County and funding for this work is available.

The Office of Procurement, in cooperation with the Bureau of Building Construction, request your approval to award a contract to Stambaugh's, Inc. in the amount of \$27,841.00 for site work to prepare for the construction of the new pavilion at the Carroll County Farm Museum. The amount is within the adopted budget.

# **Background:**

The area for the new pavilion is not level and will require some earth work. We will prepare the site by installing sediment controls and clearing the area to include the removal of one tree. Engineers will survey the area and set stakes so that accurate grading can be completed. In the areas of deficiencies, topsoil will be added, compacted, and tested to meet County standards. The last step of this process will be seeding and mulching, to help with storm water runoff until the pavilion can be built.
