ORDINANCE NO. 2021-01

WHEREAS, pursuant to the Land Use Article of the Annotated Code of Maryland, the Carroll County Planning and Zoning Commission ("the Planning Commission") has reviewed "by-request" comprehensive rezoning applications related to comprehensive rezoning;

WHEREAS, the Planning Commission, in accordance with its powers and duties conferred by law, carefully studied the areas in question, reviewed and made recommendations regarding the requested comprehensive rezoning;

WHEREAS, the County Commissioners of Carroll County ("the Commissioners"), following appropriate notice procedures as prescribed by Maryland law, conducted a public hearing and received comments on the requested comprehensive rezoning as required by law; and

WHEREAS, the Commissioners have considered the recommendations of the Planning Commission, other County agencies, and public comments and have determined it to be in the interests of the citizens of Carroll County to amend and adopt, as a comprehensive zoning action, rezoning of the following properties.

NOW, THEREFORE, BE IT ORDAINED this 14th day of January, 2021, by The County Commissioners of Carroll County, Maryland, that Zoning Maps 7, 21, 46, 52, 53, 57, 61, 62, 68, 73, 77, and 78 are rezoned as indicated on the attached Carroll County By-Request Comprehensive Rezoning Property Table.

AND BE IT FURTHER ORDAINED that the Zoning Administrator of Carroll County is hereby directed to cause the applicable changes to be made to the Zoning Maps listed above and as further described on the attached Carroll County By-Request Comprehensive Rezoning Property Table.

AND BE IT FURTHER ORDAINED, that in the event that it be judicially determined that any word, phrase, clause, item, sentence, paragraph, part or section of this Ordinance or the application thereof to any person or firm is invalid, illegal or unenforceable, the remaining provisions in the application of such provisions to other persons or circumstances and the validity, legality, the enforceability reclassifying certain property as set forth within the boundaries herein above described shall not be affected thereby, the Commissioners hereby declaring that they would have adopted the remaining provisions and their application without the word, phrase, clause, item, sentence, paragraph, part or section of the application thereof, so held invalid, illegal, or unenforceable.
