NOTICE OF PUBLIC HEARING

The County Commissioners of Carroll County will hold a **virtual** public hearing on Thursday, April 29, 2021, to begin no sooner than 9:00 a.m. to hear public comments on proposed amendments to Chapter 158, Zoning, of the Code of Public Local Laws and Ordinances of Carroll County. The proposed amendments would expand opportunities for development of community solar energy generating systems on existing remaining portions of five acres or greater in size in the Agricultural zoning district as of July 1, 2020, and are intended to increase access to solar energy, particularly for residents and small businesses. If approved, **1**) applicants would be required to convey to the County a permanent easement on the portion of the remaining portion not under solar development upon installation of a solar facility; **2**) a site plan must be submitted for review and approval by the Planning and Zoning Commission; **3**) co-location with certain agricultural uses would be required; **4**) a landscaped buffer would be required; and **5**) a plan would be required for eventual abandonment and decommissioning of the equipment/facilities.

The Commissioners may make amendments to the proposed legislation based upon the comments received at the hearing and may do so without further hearing. Therefore, it is important for interested persons to be present.
