 - Shepherd's Staff- We are accepting new coats. Call to make an appointment for drop-off. Other services are available through appointment only.
 - Nina Christian, Salvation Army- 6000 people served!
 - Jennifer Graybill, HSP's VITA program opens Tuesday, January 19th. The VITA program will be seeing clients by appointment only. Clients will drop off paperwork to tax preparer.

2. Homelessness COVID-19 Response

- a. Preparations for Night by Night Shelter/Day Center (Scott Yard)
 - There have been 57 individuals stay in the Night by Night shelter so far. That is 7 over the goal. HSP is

continuing to see new individuals. There have been 12 individuals who came to check the shelter out, grab a meal, and leave.

- Without St Paul's Church taking a leap of faith with HSP and the Night by Night shelter, HSP has been able to keep those 57 individuals safe. Thank you, Pastor Marty!
- Women should head to Stoner Avenue and Men should go to St. Paul's Church.

b. Encampment/Street Outreach (Carly Long)

- HSP & the Health Department have been going out to the encampments to deliver food, supplies, and make sure the individuals are staying healthy and connected to services

i. Updates on Outreach Efforts/New Staff

- Springboard Community Services will join the Outreach Team 1-2 outreaches per month to address any DV needs.
- HSP will drop back from Outreaches and ramp up with Rapid Rehousing in the extra dollars provided by Citizen Services.
- There are only 10-15 in encampments at this moment on Outreaches radar.

- d. Shelter Utilization Updates/Changes
 - i. Adult/Family (Joana Waters)

- The Adult Shelter is running at full capacity. HSP has partnered with the Health Department to allow all participants in the adult and night by night shelters to be being given a COVID vaccine. A special thanks to Tammy Black at Access Carroll who will be administering the vaccine for the participants.
- Family Shelter has served 13 adults and 17 children. One more family is moving into the shelter today which will bring it to full capacity.

ii. Domestic Violence (Liz Davoren)

- The DV shelter is at capacity.
- If a client meets the requirements, we will hotel them.
- In December, Catastrophic Health Planners was able to deliver a car to a DV victim at DV shelter.

3. Food Resources (Corey Hardinger)

- No one present from the Department of Social Services to speak to this item*

4. Homeless Veterans by name list update- (Amy Baker/Gina Valentine)

- Currently working with 2 homeless veterans in hotels.
- Benchmarks are holding us back from declaring we've ended veteran's homelessness.

5. Funding Updates (Debby Standiford)

- a. CDBG -COVID Round 2 Funding
 - Awarded half million dollars for Eviction Prevention through HSP program partnered with Citizen Services.
 - We are waiting to find out if we've received funding through the stimulus check. Either way, we have a lot of money!

b. ESG COVID Round 2 Funding

- We were awarded \$636,000. Half is towards rapid rehousing and will also fund hotel placement for domestic violence clients. The other half will go towards admin costs.
- This funding is for individuals who owe back rent. Although it does not go towards mortgages, HSP offers assistance in other areas such as tax preparation, and home energy assistance.
- 6. Emergency Food and Shelter Program (Claire Payne)

- Currently waiting for a new phase of funding to be released. It is anticipated to be released before our next CoC Meeting. Once it is released, Claire Payne will send out the application to the Circle to give everyone the chance to apply.

7. Youth Reach (Celene Steckel)

- 8. FFY20-Carroll County Continuum of Care Homeless Assistance Application -(NOFA)-(Debby Standiford/Leslie Wagner)
 - NOFA has been renewed for all projects in FY20. There will be a competitive round released at some point in FY21 that we will apply for

9. Virtual Learning for Homeless Youth-(Jenny Graybill/Dona Foster)

- In the Family Shelter, most of the children are been infant and toddlers. There is currently one 12 year old girl who is virtual learning. HSP transformed an area in their shelter into a classroom. Virtual learning has been difficult for this girl as she is wrapped up in family drama and unable to disconnect herself from that to give her full attention to her virtual classes.

Tutoring and Counseling services are being provided by CCPS staff on a weekly basis to students at the homeless shelters.

- Please Note- CCPS uses a different definition for homelessness. Once a student is marked homeless they stay homeless that entire year.

11. Housing Opportunities for People with Aids/HIV (HOPWA) Long Term Housing (Danielle Yates)

- Housing has signed a Memorandum of Understanding and it is in place with the Health Department. Housing is already working with one family towards obtaining a HOPWA Voucher.

12. HMIS Data update-(Danielle Yates/Shane Fox)

- PIT Count will take place on January 20th. This unsheltered count occurs every other year. The outreach team will count individuals at soup kitchens, the day center, and in the encampments. There will be no need for additional volunteers this year.
