# 2. Return to In Person Meetings for September

Please allot the necessary time for travel. We will attempt to offer a virtual component for those who still prefer this method.

### 3. Shelter Services - Utilization and Capacity/Waiting Lists

# i. Intake Coordination - Placements and Waiting Lists - HSP

Intake process-

If an individual needs shelter that day, they should go to Night by Night at 127 stoner avenue. Open 7pm-8am.

Coordinated Entry- if an individual wants to meet and go through screening process. That is available Monday through Thursday from 9-12 or Fridays from 10-12. They can call and screen over the phone anytime. Right now, the wait lists are relatively low, and it doesn't take long. No one is currently on family shelter waitlist.

Eligibility screening line- 410-386-6623. It is not a wait list, just an eligibility list. Coordinated Entry is available at the Night by Night shelter on Thursdays.

### ii. Night by Night - HSP

37 individuals were served at Night by Night in June. 22 men, 15 ladies. Half of the individuals have engaged in case management. Those that stopped coming to Night by Night have sent to Adult Only shelter.

#### iii. Adult Shelter - HSP

46 individuals were served at Adult Only Shelter in June.

### iv. Family Shelter – HSP

10 families were served at Family Shelter in June. 3 have moved into perm housing.

# v. Domestic Violence - Springboard Community Services

Safe House is at capacity. Hoteling anyone who cannot stay there due to being over capacity. SCS is currently hiring for a PRN who is flexible for all three shifts.

# 4. Day Centers-Updates/Utilization

### i. HSP Day Center

Operating a day center at St. Paul's UCC as a part of HSP's COVID services. HSP opened the day center on April 1st and it will remain open until mid-January. So far, the day center has served 67 individuals. Served a maximum number of 17 in 1 day and averaging 8 people a day. The Day Center is a place for people to come in and access laundry, shower, food, and offered coordinated entry. The Day Center currently doubles as a cooling center on extreme temperature days. The cooling center is open to the entire community. So far, 7 individuals have been served at the cooling center a St. Paul's UCC.

# ii. Cooling Centers

Carroll County Government pushes out press releases during extreme temperature days. Carroll County Public Libraries, Carroll County Senior Centers, Carroll County Veterans Independence Program, St Paul United Church of Christ, HSP Lobby, Citizen Services Lobby.

#### 5. Veterans Services

### i. Homeless Veterans By Name List (Amy Baker/Gina Valentine)

Applied for \$85,000 in grant funding that will enable us to provide emergency housing to veterans.

Courtney Edwards has been hired as the Case Manager VA Program

Ending Veterans Homelessness- we continue to meet to review the spreadsheet and try to find where the issues lie, we have reached out to TA.

We are down to 1 VASH voucher left to fill.

a. Housing Stability Coordinator Highlights

On July 22, Kerri Virtz, will start as our third housing stability coordinator. Our housing stability coordinators have been working closely with the court's docket system to aid those who need eviction prevention assistance. Our Housing Stability Coordinators can also connect those in need with work force training, energy assistance, etc. Javier Toro is continuing to work directly with those who qualify for the Mainstream Voucher program.

Housing just received 8 new Family Unification Program (FUP) vouchers. FUP Vouchers are for families who are at risk of losing children to foster care and are administered between the Bureau of Housing and the Department of Social Services.

Diversion and Shelter-Diversion focused on people as they are applying for entry into shelter. 3. Permanent Housing-Community-based housing without a designated length of stay in which formerly homeless live as independently as possible.
