2021 Work Plan Progress

Public Outreach - 2021 Environmental Stewardship **Booklet Update**

The booklet is available on the EAC's webpage and was distributed via hardcopies and/or email link to the community. Hardcopies were also provided to the delegation as a reference resource.




The accompanying infographic serves as a quick reference to some of the key information in the booklet. This format and information in the infographic were updated as well.

Public Outreach - Community Solar Zoning Text Amendment

On May 13, 2021, the Board of County Commissioners adopted an <u>amendment</u> to the Carroll County Zoning Code, Chapter 158, Solar Energy Generating Systems, to allow community solar energy generating systems (CSEGS) on remaining portions of five acres or greater in the Agricultural District.



The EAC developed a public outreach booklet to help the property owners, solar industry professionals, and the public understand the amendment, its intent, and associated requirements. The Carroll County Community Solar **Zoning Text Amendment** booklet defines community solar, describes the requirements of the amendment, shares intentions for certain requirements, reviews the adoption process, directs the reader to resources for more information, and more.

Public Outreach - Tree Planting Resource Guide

At the Board's direction, the EAC prepared a fact sheet to assist the public in finding information related to various aspects of tree planting.

This guide provides links to programs specific to Maryland and Carroll County, as well as useful online



sources of general information about various aspects of tree planting and conservation. While it is not all inclusive, it can be used as a starting point for more information on topics of interest.

2021 Environmental Action Awards

The 2021 Environmental Action Awards process incorporated and implemented the revisions made by the EAC through the awards process evaluation that occurred in 2020.



The revised awards process included a change in categories, development of nomination criteria and a ranking process, and inclusion of awards sponsored by local businesses. The EAC members solicited the awards that were presented to the winners.

The EAC rolled out the public campaign for the Environmental Action Awards in early January 2021 to solicit nominations for the awards, including, but not limited to, preparing a flyer, news release, newsletter articles, a distribution list, information on the EAC's webpage, and more. Nominations were accepted through March 1, 2021.

The EAC reviewed all nominations, and winners were selected in March 2021. An awards presentation ceremony was



held at the Westminster Community Pond, where the awards were jointly presented by the EAC and the Board of County Commissioners.

Public Outreach – Residential Graywater Use in Carroll County

Graywater is untreated water collected from a clothing washing machine or a bathroom sink, tub, or shower. While not drinkable, it is suitable, and even beneficial, for irrigating certain areas of the yard, which also helps to conserve water usage. The 2018 Maryland General Assembly passed legislation (Senate Bill 496/Chapter 705) to allow residential graywater for certain uses. The legislation requires Maryland Department of the Environment (MDE) to develop regulations to implement the bill's provisions.

Per the 2018 Work Plan and continued to the 2019, 2020, and 2021 Work Plans, the EAC will research homeowner graywater usage and prepare public outreach materials to help provide Carroll's residents with basic information regarding

graywater, its residential uses, and its benefits. The materials will be made available in hardcopy and online.

The EAC is currently waiting on regulations to be released by MDE.

These regulations need to be available before the EAC can inform the public of the process(es) and requirements associated with use of residential graywater in Carroll County.

2022 Work Plan

The EAC developed a <u>work plan</u> for proposed projects to be completed during the 2022 calendar year. On November 17, 2021, the EAC approved to

recommend these proposed projects to the Board. The work plan will be finalized pending discussion, any additional projects requested by the Board, and concurrence by the Board at the annual joint meeting with the EAC, which is typically held in late January.

PENDING BOARD CONCURRENCE

Solid Waste Committee Service on Solid Waste Advisory Council (SWAC):

The SWAC, which is facilitated by the Department of Public Works (DPW) staff, serves in an advisory capacity to the DPW regarding implementation of recommendations from the former Solid Waste Work Group's report, input on potential capital projects and future directions, as well as public outreach efforts. An EAC member typically serves on the SWAC as a liaison between the two groups to allow for additional collaboration and input to the SWAC. The SWAC has been inactive. Therefore, with Ellen Cutsail's resignation from the SWAC, a replacement EAC liaison has not yet been chosen.

ONGOING - NO ACTIVITY IN 2021

Actions Taken

Due to the COVID-19 pandemic, many of the regular monthly meetings for the EAC were held virtually via GoToMeeting. The agendas for these meetings are posted on the County's Upcoming Meetings, Agendas, and Public Hearing webpage. When virtual, access to call into the meeting to participate is available for the public. Meeting summaries are posted on the EAC webpage once approved.

- 2021 Environmental Action Awards:
 - ➤ The EAC members secured donations of gift cards for the winners and a scholarship for the student winner.
 - On March 2, 2021, the EAC members received for review the nominations submitted. Review and ranking were completed by March 12, 2021.
 - ▶ Winners were notified in mid-March 2021.
 - ➤ The EAC jointly presented awards to the winners with the Board at a ceremony at

Westminster Community Pond on April 21, 2021.

- Public Outreach Community Solar Zoning Text Amendment Booklet:
 - Per the 2021 Work Plan, upon adoption by the Board of the Community Solar Zoning Text Amendment, the EAC prepared a booklet to assist the public in understanding the requirements.

 The EAC approved the booklet on May 19, 2021.
- Public Outreach 2021 Environmental Stewardship Booklet:
 - Work Plan, the information in the booklet was updated to current information and new information added. The EAC reviewed the content and approved the final document on June 23, 2021.
- Public Outreach Tree Planting Resource Guide:
 - ➤ Per the 2021 Work Plan, the EAC developed a one-page guide with links to web resources related to various topics related to tree planting. The EAC reviewed approved the guide on June 23, 2021. It is available online.
- Work Plan:
 - On January 28, 2021, the EAC and the Board of County Commissioners held their annual joint meeting to review the 2020 Annual Report and discuss the proposed 2021 Work Plan.
 - ▶ In fall 2021, the EAC drafted a proposed 2022 Work Plan in preparation for the annual joint meeting with the Board, which will tentatively be held in late January 2022.
 - ➤ On November 17, 2021, the EAC approved the proposed work plan as a recommendation to the Board.
- Annual Report:
 - ➤ The 2021 Annual Report to the Board was reviewed on January 19, 2022 and approved as a final product to present to the Board.
- Member Removal:
 - ➤ On April 30, 2021, the EAC voted to recommend removal of two members, Ellen Cutsail and Natalie Kartalia, who were unable to commit the time needed to EAC responsibilities. The EAC Chair forwarded the recommendation to the Board.
