OVERVIEW OF FUNDING — 1:00 pm - 1:05 pm Carroll County's FY23 allocation increased by \$85,109 for a new total of \$575,348.

- a. The use of this funding must relate to children, youth, and family service provision in Carroll County.
- b. While the additional \$85,109 has been allocated by the state to our FY23 budget, <u>we must wait until the</u> <u>end of the legislative session</u> for final confirmation. It is unknown whether the additional \$85,109 will remain in our FY24 budgets or beyond, so we are essentially planning a one-year strategy.
- c. Strategies for this funding <u>should align with the FY23 Community Partnership Agreement (CPA) Notice of Funding Availability (NOFA)</u>, specifically the Eight Results for Child Well-Being (see pp. 4), the three themes/lenses (see pp. 5), and the program/strategy priorities (see pp. 12-15, section VII-A).
- d. When we discussed what to do with additional funding last year, the Board voted to fund something related to behavioral health/trauma.
 - 73% of our **voting** Board members responded: 64% — Behavioral Health/Trauma 27% — Employment/Labor Crisis 9% — Housing Assistance 0% — Transportation, Pandemic Recovery, ACEs/Learning Loss, Daycare/Head Start, Other
- e. It is up to the CCLMB Voting Members to make the ultimate decision on how to spend this funding.
