3. Vote on Jason Sidock being presented before the CoC for the formal consideration on the Executive Committee

Voted into the Executive Committee with no objections

4. Access Carroll Updates – Tammy Black

- Open 7 days a week; have triage set up for dental care, huge waitlist
- Covid-19 protocols are still in effect; they are still masking, and patients are doing a temperature check
- Two designated parking spaces will remain designated for COVID testing; have been helpful in identifying testing subjects

5. HSP Updates

a. Shelter Utilization/Vacancy Update

- Adult Only has served 33 different people, 6 people moved out and 5 went to perm housing; bed bug room closure; 2 male openings; 5 of the 8 women with housing opportunities, just waiting on place; 3 men waiting on place
- Family shelter served 12 adults and 15 kids; 1 family moved to perm housing; no openings; 3 or 4 babies right now
- Night by Night 22 highest and 14 lowest; uptick seen in elderly and medically vulnerable population

b. Perm Housing Update

• no turnover; no update; monitoring visit with Citizen Services

c. Eviction Prevention Update

• Not many changes

6. Day Center

- served 42 people in March; that is a low number from previous months; 15-20 come and go each day
- Day Center at St. Paul is generous and willing to stay open as long as they can
- Utilization was 46 different individuals at Day Center in February; data shows 71% of Day Center enter Night by Night shelter

7. On Our Own – Laurie Galloway & HSP

- open 7 days a week; before covid 35-40 people a day, since covid started about 25 people a day
- Have the ability to sign people up for services
- Hours are 9am-3pm; not providing food in evenings; hours can be flexed if they need to be if need is there for later hours
- Eligible participants must be 18 and older working on recovery; can't come if intoxicated; they have 18–75-year-old
- 95% of incoming participants are homeless; most of the folks cross over and go to the day center

8. Outreach Efforts – HSP/Health Dept./Springboard

- Joanna: Judy is going to libraries and convenience stores to find a different demographic
- Amy Baker Resource Fair later in the Spring when weather is more cooperative
- Resource Fair Update on the next outreach meeting agenda

9. Shelter Plus Care-Amy Baker

- just housed a family last week; another single person waiting on 1 bedroom
- got permission to look for two-bedroom apartments; can take on two additional individuals through coordinated entry

Vote to accept updates to Housing Services Coordinated Entry- Shelter Plus Care Procedures

• Keeping in draft format and will table the vote-Amy Baker recommended additional changes. Will meet with CE Subcommittee to review.

10. Veterans Services Update – Gina Valentine & Jason Sidock

- 4 homeless veterans became housed
- Received donations from Catholic War Veterans toilet paper, soap, laundry detergent, silverware, plates
- May 15th Celebration announcement

- Met with HUD and received technical assistance; reviewed benchmarks; once application is received, they will send it to a review committee
- Thank you to Deputy Colussy for all his support
- BOAD 50th Celebration announcement
- AARP application approved
- Veterans Claims Clinic June 7th 9am-3pm.
- Jason Sidock assisted 3 veterans in positive outcomes in court cases
- 4 additional Veterans processed for benefits total to 21
- 5 approved to receive benefits
- Caseload increased to 93
- March 29th, National Welcome Home
