- 8. Affordable Housing Subcommittee Development
 - a. Carroll County Landlord Association president or board members would be good to include
 - **b.** Drew (??) sits in on these meetings
 - c. Housing Stability Team and Danielle can attend
 - **d.** Jenny Graybill and Samantha (HSP new hire)
 - e. Eric Brown suggested we need to define what affordable housing is
 - f. Jenny Graybill has sat on a committee that has developed low-income housing
 - g. Legislative Committee Scott Yard
 - i. Tax credits
 - ii. Waiving fees
 - **h.** HUD defines Affordable Housing as 30% of gross income
 - i. Danielle Yates payment standards are 110% of FMR
 - j. HUD wavier may be extended after December 31, 2022
 - k. Further Discussion on Barriers to Affordable Housing
 - i. No resources exist for Spanish speakers and environment is not conducive for Spanish speaking population
 - ii. Youth Homelessness also is difficult because they do not like the shelters
 - iii. Accessible Housing for clients who need housing on first floor there is a shortage
 - iv. Domestic Violence population consider rents are high and unaffordable and lack of options
 - 1. Committee needs to define how we are going to address these issues
