## 5. CCLMB Strategic Planning Efforts — CCLMB Staff & Carrie Freshour Consulting, LLC.

An outcome of the Community Assessment process was the knowledge that intentional strategic planning efforts are necessary in FY23. This fiscal year Gabby will engage Board members and others within the partner agencies in these efforts through events such as:

- A Board Member Orientation/Training At least 1/3 of the Board are new or came on during COVID. This will bring the Board together to regroup from COVID and dial in on LMB initiatives.
- A Planning Session & Turn The Curve Utilizing Results-Based Accountability (RBA) and Turn The
  Curves, the Board will use this Community Assessment data to identify community needs and
  direct our attention, funding, and programming to those needs.
- <u>A Board Member Planning Retreat</u> Finalize the Board's discussions and refine the Board's next steps to create a Strategic Community Plan.
- <u>Self-Assessment</u> To kick these events off, Board members will be asked to complete a self-assessment regarding typical Board member roles and items specific to the LMB.

#### 6. Youth REACH, Youth Homelessness Subcommittee, & Youth Action Board — CCLMB Staff

- Youth REACH MD Data: Local data from the 2022 Youth REACH MD Youth Count was shared with the group (see the Carroll County Youth REACH Briefing Packet for details). Please Note: The 2022 data is still being reviewed by the Institute for Innovation and Implementation and is subject to change until the final 2022 Youth REACH MD Youth Count report is published.
- Youth Homelessness Subcommittee: The YHS has met virtually at 10:00 am on the second
  Wednesday of every month since August 2022. Visit our website to read our goals and see the
  participating agencies and organizations. Subcommittee members are creating a resource and
  gap map, streamlining and synthesizing data on youth homelessness with other homeless data
  collected in our community, and have engaged youth in creating a Youth Action Board.
- Youth Action Board: Carroll County's YAB is meeting weekly in November and will meet monthly starting in December. They established an Executive Team with a President, Vice President, and Secretary. There are at least 10 participating youth with some as young as 11. Youth interested in participating in the YAB must be under age 25 (youth under 12 need parental consent to participate) and live or work or attend school in Carroll County.
