WHEREAS, by adoption of Resolution No. 815-2011 on February 22, 2011, the County Commissioners of Carroll County resolved that they would not increase the tax rate for real or personal property, admissions and amusements, hotels, 911, or income, unless the increase is approved by at least four of the five Commissioners; and

WHEREAS, the 62nd Board of County Commissioners of Carroll County wishes to strengthen the taxpayers protection set forth in Resolution 815-2011.

NOW, THEREFORE, IT IS HEREBY RESOLVED, that THE BOARD OF COUNTY COMMISSIONERS OF CARROLL COUNTY, MARYLAND, shall not repeal the taxpayer protections set forth in Resolution 815-2011 unless such action is approved by at least four (4) of the five Commissioners.

This resolution shall take effect immediately upon its execution.

IV. Request Approval for Grant Application and Acceptance of Award –Carroll County Restoration Projects

The Bureau of Resource Management (BRM) is seeking \$2,370,000 from the Maryland Water Infrastructure Financing Administration (MWIFA), Bay Restoration Fund Wastewater Program to fund best management practices to address requirements of the County's National Pollutant Discharge Elimination System (NPDES) Permit in various watersheds throughout the County. These projects meet watershed goals of improving water quality through reduction of sediment and nutrients; reducing thermal impacts to the receiving waterways; and integrating green infrastructure practices. These projects are in predominantly residential areas and include over 281 acres of drainage area, including over 124 acres of impervious area that will be treated by the proposed facilities.

V. Public Safety Training Center Stormwater Retrofit – MDE Loan Application

The Bureau of Resource Management (BRM) is seeking \$1,000,000 from the Maryland Water Infrastructure Financing Administration (MWIFA), Water Quality State Revolving Loan Fund Bipartisan Infrastructure Law Funding for PFAS/Emerging Contaminants to fund the retrofit of the stormwater management facility that serves the Public Safety Training Facility. In addition to addressing nutrient reduction requirements of the County's National Pollutant Discharge Elimination System (NPDES) Permit, this facility retrofit will convert a wet pond into a lined surface sand filter in an effort to reduce PFAS soil contamination from entering the local stream. Because this project is requesting a loan, the entire construction cost of the facility is eligible to be included in the application as well as reimbursement of engineering design costs. This loan is eligible for principal forgiveness.

VI. Presentation Regarding Community Solar Code – Information Only

In 2021, the Board of County Commissioners adopted a text amendment to Chapter 158 of the County Code to allow community solar energy generating systems (CSEGS) on certain remaining portion parcels in the Agricultural Zone. Requirements for community solar facilities include, among others, a landscaped buffer along public rights-of-way and contiguous residential properties, colocation with agricultural uses, and a conservation easement on the portion of the property not used for the community solar facility.

VII. Installation of Pole Lighting at the Carroll County Farm Museum

The Office of Procurement in cooperation with the Bureau of Building Construction requests your approval for the installation of the pole lighting at the Carroll County Farm Museum in the total amount of One Hundred Ninety-Nine Thousand Five Hundred Twenty-Two Dollars and Twenty Cents (\$199,522.20) to Eastern Sales and Engineering Company, Inc. This purchase is being made through a Charles County Contract #RFQ 20-19 that was competitively bid. This amount is within the approved budget and no additional funds should be necessary.

The project is located at the Carroll County Farm Museum, at 500 South Center Street. This project will consist of the removal of 14 compromised wood poles and fixtures. Included in the project are three additional poles and fixtures which will be installed to provide adequate parking lot lighting. New electrical wiring is also in the project which will be required to support the lights, pole receptacles and to meet current electrical codes.

IX. FY24 Annual Transportation Plan

Carroll Transit System provided over 70,000 passenger trips in FY22 to older adults, persons with disabilities, and the general public through demand response (door-to-door) service and the TrailBlazer (deviated-fixed routes). Over 49,000 trips have been provided to date in FY23 with a fleet of 40 vehicles.

Six TrailBlazer deviated-fixed routes operate in North Carroll, Taneytown, and Westminster. The service operates Monday through Friday. The TrailBlazer system has provided just under 13,000 passenger trips through December of FY23.

Demand Response (door-to-door) service operates Monday - Friday and currently accounts for 73% of the rides provided by the system. Riders are transported each day throughout the county with an average trip length of 6.5 miles. Riders are primarily elderly and/or disabled and use demand response for medical, employment, social service, and general-purpose trips.

Public transportation is funded in Carroll with a mix of grant funding from the Federal Transit Administration (FTA) and Maryland Transit Administration (MTA), fare revenue collected by the vendor, and County funding.

In order to include public input in the development of the Annual Transportation Plan, the opportunity to request a public hearing will be advertised by January 26, 2023. If a public hearing is requested, it will be held in open session on February 23, 2023. The preliminary FY24 budgets will be included in the advertisement for the public hearing.

The Board of Commissioners will approve the FY24 Annual Transportation Plan with final budgets prior to submission to MTA in March.
