## Public Information Notice Pending Shepherds Mill Road Closure in 2020/2021

The Carroll County Department of Public Works is currently proposing to replace Bridge No. CL245 Shepherds Mill Road Bridge over Little Pipe Creek. The purpose of this release is to provide outreach to the general public about the future bridge replacement and tentative timeframe for construction during the 2020/2021 construction season.

The existing three span bridge will be replaced with a new single span steel girder bridge. The new structure will be constructed in the same location as the existing structure. It is anticipated that construction will occur during the 2020/2021 construction season and will take approximately six to eight months. Shepherds Mill Road at MD75 (Green Valley Road) will be closed to through traffic prior to starting construction and a detour will be established to divert traffic around the project using MD75 (Green Valley Road), Union Bridge Road, Locust Street, and Quaker Hill Road. Shepherds Mill Road near Quaker Hill Road will remain open to local traffic.
