# Carroll County Commissioners Begin to Analyze Freedom Plan and Update Meeting Schedule

**Westminster, MD, September 15, 2017** – Yesterday, the Board of Carroll County Commissioners (BCC) began deliberations on the <u>Freedom Community Comprehensive Plan</u>.

During the meeting, the BCC discussed their strategy for deliberating the plan. The Commissioners acknowledged their responsibility to set the direction for what they want the Freedom Plan to accomplish. They value public input and want to honor the public's request to understand the changes to the plan. Therefore, the list of properties changed in the Freedom Plan will be thoroughly reviewed one-by-one to determine the rationale, benefit and cost for each change. The Carroll County Planning and Zoning Commission provided a thoughtful and comprehensive plan from which the Commissioners will work.

After what was deemed a positive start to deliberations, the board's consensus was to continue discussions to avoid returning the plan to the Carroll County Planning and Zoning Commission. Ultimately, the BCC decided to add a work session for more open discussion before the Open Forum scheduled for September 21, 2017. To this end, an additional meeting to continue deliberations is scheduled for Tuesday, September 19, 2017 at 2:45 p.m. in Room 311 of the County Office Building, 225 N. Center Street, Westminster. The focus of this meeting will be clarification and discussion of the concepts (or rationales) identified in the plan.
