#### CALL TO ORDER/WELCOME

# **ESTABLISHMENT OF QUORUM**

Laura Bavetta took attendance and noted that seven members of the Board were present and a quorum was in attendance.

#### **PLEDGE OF ALLEGIANCE**

#### REVIEW AND APPROVAL OF AGENDA

Secretary Eisenberg noted in the Revised Agenda that Item 10 was removed. The Revised Agenda was approved on motion by Mr. Yeo, seconded by Mr. Wothers, and carried.

# **ADMINISTRATIVE REPORT**

#### A. Administrative Matters

Secretary Eisenberg explained to the Commission that the Freedom Community Comprehensive Plan was removed from the Agenda because the Board of County Commissioners rescinded the remand of the Plan.

#### B. Other

Commissioner Wantz explained his thoughts behind the Board's decision stating the importance for the current Board to complete the Plan. The Commission members voiced their opinions about the Board's decision to rescind the remand of the Plan stating they were blindsided by the Board's actions and believed they were following the Board's direction based on the letter sent to the Planning Commission following the remand on October 3, 2017.

On motion of Mr. Hoff, seconded by Mr. Wothers and carried, the Commission voted to close session for legal advice at 6:32 p.m.

At 6:50 p.m. the Commission reopened session.

Ms. Gail Kessler recused herself based on a conflict of interest. On motion of Mr. Hoff, seconded Ms. Kirkner and carried, the Commission voted to obtain independent outside legal counsel regarding the Board's decision to rescind the remand of the Plan.

# BICYCLE-PEDESTRIAN MASTER PLAN - CHAPTER 6 ACCEPTANCE

Clare Stewart updated the Commission on Chapter 6 of the Bike-Ped Master Plan. Vice Chair Cheatwood asked which Agencies will oversee the implementation of the Plan. Secretary Eisenberg stated the Department of Planning, Recreation and Parks, and the Towns will all help in the process.

On motion of Mr. Yeo seconded by Mr. Wothers and carried, the Commission voted to approve Chapter 6 of the Bicycle Pedestrian Master Plan.
