Call to Order: Tom Irwin called the meeting to order at 11:04 a.m.

<u>Approval of meeting minutes</u>, <u>June 18</u>, <u>2025</u>: Mark Savage made the motion to approve the minutes as written. The motion was seconded by Phil Snader, motion carried unanimously.

Request for a child lot by Henry Shirley, Patricia Shirley, Glen Shirley, Deborah Shirley, and Elaine Shirley, on behalf of Barbara Shirley, Barnhart Road, Westminster, MALPF Easement: JP introduced Mr. Glenn Shirley. JP explained the request to the Board and the location of the child lot. JP recommended the request for approval. Mark Savage made the motion to approve the request as written. The motion was seconded by Phil Snader, motion carried unanimously.

Request for an unrestricted lot and lot location for Mara Mullinex, 1330 Baust Church Road, Union Bridge, County Easement: JP explained the request to the board and the location of the unrestricted lot. JP recommended the request for approval. Phil Snader made the motion to approve the request as written. The motion was seconded by Alice Altstatt, motion carried unanimously.

Request for an unrestricted lot and lot location for Dim Vovkiv LLC, Frank Wodoslawski, 3617 Old Taneytown Road, Taneytown, County Easement: JP introduced Mr. Frank Wodoslawski to the Board. Mr. Wodoslawski introduced his family and explained the request to the Board and the location of the unrestricted lot. This property was perked 96 times, and this location has a good perk. Mr. Wodoslawski will put verbiage in the Deed stating the lot has to remain in the same ownership as the farm. JP recommended the request for approval.
