Ms. Eisenberg earned her Bachelor's Degree in Environmental Studies from University of Maryland, Baltimore County and holds a Master's Degree in Geography and Environmental Planning from Towson University. She has over 20 years of experience as a planning professional and an extensive background in Maryland planning and land use programs as well as federal and intergovernmental planning issues. She is a published contributor to several planning-related publications and is active on several boards and committees.

Ms. Eisenberg is originally from Calvert County, Maryland and has lived in this region for more than 25 years. She is married with two children and enjoys skiing, hiking, biking, volunteering at her children's school and coaching field hockey.
