

## **CARROLL COUNTY ELECTRICAL BOARD**

**October 26, 2017**

**PRESENT: P. Noyes, D. Sullivan, D. Coppersmith, D. Brosenne, H. Lambert  
S. Bassler, J. Green, and B. Wetzel.**

Notice of this meeting was provided to the public by mailing notice to members of the Carroll County Electrical Board, posting notice electronically on the County's website, and posting notice physically on the County Commissioners bulletin board.

### **CALL TO ORDER:**

Meeting was called to order at 11:00 A.M. by Mr. Noyes, Chairman at the Carroll County Office Building to administer Electrical Licensing Examinations #91. Seven applicants sat for the Masters Exam. Each applicant had four hours to complete the exam. No applicants sat for the Restricted Exam.

A copy of the minutes from the August 16, 2017 meeting was e-mailed to each board member. Mr. Lambert made a motion to accept the minutes as written. Mr. Brosenne seconded the motion and vote was unanimous by the Board.

### **OLD BUSINESS;**

The Board Members unanimously voted to eliminate the homeowner's exam. Jason will present this to the County Commissioners. If approved by the County Commissioners, the timeline for elimination will be approximately around the beginning of 2018.

### **NEW BUSINESS;**

Mr. Noyes read and approved the Advisory Board Mission Statement. Mr. Green requested a motion be made to accept the Mission Statement as written. Mr. Coppersmith made the motion and a vote was unanimous by the Board.

Mr. Bassler said there is a Carroll County Employee who is interested in taking the Limited Master Exam. Mr. Bassler will work on selecting questions for the exam if requested by the board. Mr. Bassler also mentioned that the Limited Master Exam may be given at any time as long as the Board Members are in agreement and two Board Members are present for the exam. Mr. Sullivan made a motion to have Mr. Bassler select the questions for the Limited Master Exam. Mr. Brosenne seconded the motion and a vote was unanimous by the Board.

Mr. Green mentioned the Master Restricted License Exam questions and a test will be developed for the 2017 National Electrical Code book at a later date.

Mr. Sullivan mentioned low voltage wiring in new residences and commercial jobs. Beginning January 1, 2018 low voltage wiring will be charged to the Contractor, not the electrician.

Meeting adjourned at 11:30.

The meeting was reconvened at 1:00 P.M. to grade the Master Electrical Exams. None of the applicants passed the Master's Exam. Their scores are as followed:

Julio C. Trujillo scored 59%  
William Stiffler scored 36%

The next meeting will be held on Tuesday, February 21, 2017 at Baugher's Restaurant to select questions for the next electrical licensing Exam #92 to be given on April 25, 2018. Mr. Coppersmith made a motion for the meeting to adjourn. Mr. Lambert seconded the motion and was unanimously carried by the Board.
