Please remember that the address and company name on your Carroll County Plumbing/Gas/Utility License <u>MUST</u> reflect the address on your Maryland Statewide Master Plumbing/Gas/Utility License and/or other reciprocating county license. IMPORTANT: The license application must be signed by the licensee.

<u>Master Plumber/Gas Fitter License</u>: please provide a copy of your active Maryland Statewide Master license and a copy of your driver's license. The fee for the license is \$100.00 for Master Plumber/Gas fitter or \$70.00 for Master Plumber. The license is valid for two years and will expire June 30th of the odd year. PLEASE NOTE: You will **not** need to send a copy of your certificate of insurance.

Inactive Master License: please provide a copy of your Maryland Statewide Master license and a copy of your driver's license. The fee for an Inactive Master Plumber/Gas Fitter license is \$50.00 and \$35.00 for an Inactive Master Plumber license. The license is valid for two years and will expire June 30th of the odd year.

<u>Gas Fitter License</u>: please provide a copy of your active Maryland Statewide Gas Fitter or City of Baltimore license along with a copy of your driver's license. The fee for the gas fitter license is \$70.00 for two years and will expire June 30th of the odd year.

<u>Utility License</u>: please provide a copy of your current utility license from another county and/or from Carroll County, a copy of your driver's license, and <u>a Certificate of Insurance in the amount of \$300,000 for general liability and \$100,000 property damage showing the Carroll County Commissioners as payee. PLEASE NOTE: We no longer accept bonds. The fee for the utility license is \$50.00 for two years and will expire June 30th of the odd year.</u>
