<u>CALL TO ORDER</u> – Robyn Gilden called the January 11, 2011, meeting to order at 3:00 p.m. <u>Motion 121-11</u> to approve the minutes with revisions to "Old Business" #2 from the November 9, 2010 meeting was made by Karen Merkle and seconded by Dave Pyatt. The motion carried and was approved.

<u>COMMUNICATIONS</u> – No communications were received this month, however, Dave Pyatt wanted to tell the council about a function he had attended. He spoke with an engineer who is working on RDF (Refuse Derived Fuel) for Lehigh. The company is working with the Maryland Department of the Environment for approval of this.

Also, Robyn Gilden informed the council that she had sent a letter to the new Board of Commissioners introducing the EAC and its goals. She received two responses, one from Doug Howard and one from Robin Frazier in support of our group.

**PRESENTATIONS-** No presentation will be made this month.

# **OPEN FORUM-**

- 1. Karen Moody introduced herself to the council as an advisor to the Environmental Science Group at Carroll Community College. She wanted to emphasize that more information needs to be publicized regarding recycling. She feels more education is needed in the community, maybe a flyer should be put with the Water bill for the citizens within town limits or with the bill from the haulers. Chris Spaur suggested having students update a web site as a school project. Cindy Parr told the council that Kevin Carmack and Chris Swam of the video department with Carroll County Government had created a cartoon type of educational video called "It's Fun to Recycle with Pete the Plastic Bottle", which can be viewed on the County website.
- 2. Ellen Cutsail of Union Bridge voiced her opinion that the new Commissioners feel the Waste to Energy Facility is not important. She suggested letting the new Commissioners know of past research that the EAC has done.

#### TREE COMMISSION -

Brian Rhoten gave reports on the Tree Commission meetings that have been held the past 2 months.

The December tree committee meeting was held December 1 at 10:00 in Room 205 of the County Office Building. Discussion was held regarding property line disputes in critical root zones. When submitting an Environmental Site Delineation application, the developer needs to include a copy of the letter that they sent to adjacent property owners with concerns. When a complaint is received the response will be an inspection completed by an inspector from the Bureau of Resource Management Office.

The Council decided that Terri Jones would write the recommendation to the Commissioners to include proposed language to this change and notify Resource Management of this recommendation. A cover letter from Robyn will be forwarded to Cindy Parr for presentation to the Board of Commissioners.

<u>Motion 122-11</u> was made by Karen Merkle and seconded by Kim Petry to recommend the revised ESD requirements. All were in favor.

The January meeting was held on January 5 at the County Office Building in Room 205 at 10:00. The topic of discussion was Public Education regarding Tree Preservation. Arbor Day plans were also started. The question of where to plant trees was brought up. Bear Branch Nature Center was a suggestion. Brian would like to plant trees at the median at Winters Mill roundabout to the Pizza Hut. Maintenance of the area around the trees is an issue. The following suggestions were made:

- 1. Planting trees in recognition of the Environmental Awareness Awards.
- 2. Westminster Elementary School has a sloped area that may be an option to plant on.
- 3. The median on Route 140 is not a good option due to safety issues.
- 4. Bowling Brook which is now the Silver Oak Academy was suggested as a location to plant trees.
- 5. Contact Steve Reynolds (Sherriff's Warden) to arrange to have inmates help with plantings.

## **OLD BUSINESS** –

#### 1. Nominations for a new Chairperson –

- a. Dan Andrews declined
- b. Sandy Zebal was nominated by Dan Andrews, seconded by Dave Pyatt. Sandy accepted. The vote was unanimous for Sandy to be chair. She will take over at the March 2011 meeting.

#### 2. Work Session -

Karen Merkle reported on the sub-committee meeting held November 29. Three topics were focused on.

- a. Residual Ash Dan Andrews has been finding information from other counties. He is trying to find a report of composition of this ash to see if it is considered a hazardous material.
- b. Hauling Routes in Carroll County Brian Rhoten reported that 13-15 haulers are collecting in the county.

c. Pay As You Throw – Karen Merkle told the group that there are currently no incentives in place for the haulers. The sub-committee is going to study this further. A hauler will be invited to a meeting to give more information.

\*\*Brian Rhoten was tasked with finding information on Baltimore county solid waste practices. Please see his notes attached to these minutes.

Another meeting was held on January 6 to continue discussion on these topics.

The group voiced interest in having Maria Myers come and speak again and/or Chuck Ingram, Bureau Chief of Solid Waste. They would like to know what education is being encouraged by the haulers concerning recycling. An itemized report of the cost to recycle is being requested. The committee decided to hold another meeting to discuss more of this information.

#### NEW BUSINESS-

- 1. Donna Davis of the Forestry Board would like the EAC to have an ordinance with guidelines of keeping property mowed 50' from the property line.
- 2. The next meeting will be held March 8 at 3:00 in the afternoon in Room 003.

Basically Baltimore Co. puts 1/3 in out of state landfills, 1/3 in incinerator and 1/3 of waste in county landfill.

They use 49 haulers and the county pays haulers to collect all curbside garbage for residential. Cost for collection is 27 million on 400 tons per year. 67.50 per ton to collect. The have 320,000 units. (collection sites) 1.25 tons annually per site

The cost to the county for disposal of the waste is 55 per ton.

The recycling rate on curbside is 13.4% these are true numbers no additional figures calculated, such as road waste etc. 399,935 tons collected of waste and 53,612 tons of single stream recycling collected. 38,267 were the tons of recycling collected when they were separating recyclables. These figures do not include yard waste or drop off figures, just curbside.

They have single stream recycling and a yard waste compost facility.

Mrs. Leatherwood spoke to the council about how their trash collection works in Sykesville. A customer buys 20 tags for \$50.00 or \$2.50 per bag. Each bag should weigh no more than 40 lbs. and have 1 tag attached. The bag is to be a 33 gal. size. There is no charge for unlimited recycling. An additional fee is charged for yard waste or a Tote. Positive feedback has been received from the customers. Customers are recycling more and many are putting out less than 40 lbs./33 gal. of trash.

#### **OPEN FORUM**

1. Judy Smith of Union Bridge is concerned with the renewal of Lehigh's Permit by MDE <u>before</u> proposed changes in emissions regulations occur and the existence of less stringent emissions

regulations for cement plants vs. incinerators using refuse derived fuel. There is an Environmental Integrity Report that will be e-mailed to council members.

2. Jay Hull, a local real estate agent, who is also a 5<sup>th</sup> generation Carroll County family feels his rights as a property owner will be taken away, if the septic ban is approved. Mr. Hull's other concern was about forestation laws which restrict the amount of open land on wooded lots thus limiting buildable space, in his opinion. It was suggested by a council member that he contact county staff for further information regarding the reforestation policy.

**<u>CALL TO ORDER</u>** - Ms. Sandra Zebal, Chair, officially called the May 10, 2011, meeting to order at 6:30 p.m. asking for approval of the March 8, 2011 minutes.

<u>APPROVAL OF MINUTES</u> – MOTION NO. 126 -11: Motion was made by Robyn Gilden, seconded by Dan Andrews, approving the minutes. Motion carried.

Sandra also pointed out that a Secretary's Note had been added to the January minutes referring to the Attachment of Brian Rhoten's notes from the waste subcommittee's discussion on Baltimore County's practices.

#### **COMMUNICATIONS** -

- 1. Robyn was contacted by Steve Powell in January stating that he will let the council know when the Tree Committee's recommendation on the ordinance change is on the Agenda and if someone needs to attend. The Budget has top priority right now. Cindy Parr advised Robyn to send the information again to Steve Powell and Tim Burke.
- 2. Karen Merkle asked if any communication had been received regarding filling the open position on the council and will current members be notified of the term expirations. Dan Andrews and Karen Merkle's terms are expiring in July of this year. The Council voiced their wishes that these two members would accept re-appointment. They feel it would be a great loss if Dan and Karen were not to stay on.

#### **PRESENTATIONS:**

(Tonight's meeting is not being video broadcast due to staff shortages. Cindy Parr informed the Council that another video person will be starting on May 26 and future meetings may be taped.)

#### 1. Maria Myers – Carroll County Recycling Coordinator

Ms. Myers spoke to the council about how the recycling efforts are progressing. She gave everyone handouts with information showing an increase from 2008 to 2009 of diverted tonnage of trash. All 3 haulers in the County showed an increase. Most recent MDE figures are from 2009.

A grant received was used to purchase bins for Carroll County residents. They were all given out and requests for larger bins were received.

A new brochure to encourage business recycling is being produced through the Carroll County Chamber of Commerce and Economic Development. Multi-family units are starting to recycle. Restaurant composting is being encouraged.

A fluorescent bulb program has been mandated by the state. Chris Spaur informed the Council that button cell batteries have more mercury than bulbs. Discussion followed regarding recycling batteries. A Hazardous Waste Drop-Off Day is scheduled for May 14. (See Carroll County web-site for more information)

The Swap Shop at the Carroll County Landfill is now manned by Goodwill. Safety reasons were mentioned as one reason for this change. Styrofoam collection is to be added and cooking oil for bio-duel collection is continuing.

Maria informed the Council that she received certification as a Master Composter last month.

Freedom Elementary School is beginning to compost. Mt. Airy Elementary School Green Team has made a video about recycling that will be used as an educational tool.

A Guide to Recycling booklet is coming to the Web and there is now a Facebook page – Carroll County Maryland Office of Recycling.

Maria now has a volunteer in her office to work on events and brochures.

Ms. Zebal expressed a concern about the shortfall in the cost of recycling in 2010. Ms. Myers explained that this is partially due to the cost of staff and equipment. In addition, she said that due to the contract the county has with Recycle America we are not able to shop around for better pricing on recyclables.

# 2. Emily Peterson – South Carroll High School Student

Ms. Peterson came back to the Council to update them on her progress with composting at South Carroll High School. Students built a facility for composting. Aluminum was donated from State Highway Administration to make the 12' x 6' structure. Food scraps and mulch are layered and a bucket loader is used to turn the compost. Emily is graduating this year and will be attending St. Mary's College with a biology major. The school has an Environmental Club that will be taking over the composting responsibility. Another contact is Science Teacher, Ms. Plaskowitz.

Ms. Peterson informed the council that Allegheny County has an energy manager for the schools and expressed her opinion that it would be a benefit for CCPS to do the same.

#### **OLD BUSINESS** -

1. Tree Committee - Brian Rhoten via e-mail -

#### Sandy/Cindy

I am not going to make this evenings meeting. Sorry.

Related to the last two tree commission meetings, arbor day went well.

The last subcommittee meeting we talked about many of the commissioners suggested changes to the landscape ordinances, and the general concensus of the tree commission subcommittee was that we should not support removing the street tree requirements. Currently the ordinance states that a major tree be planted every 40 feet, we suggest reducing the spacing to 50 feet, which will be 25% LESS trees required. The ordinance currently states that a minor tree be planted every 20 feet, we suggest reducing this spacing to 25 feet, 20% LESS trees required, but completely eliminating street tree requirements was not supported by anyone at the last subcommittee meeting. Another major component was the bonding to the developer being returned after planting was completed, our suggestion was to return 65% of the bond after planting (inspection) and 35% after inspection and survival of all of the plants after one year. To require plants, but not hold a bond on their survival will not encourage high quality stock or installation precautions. This is about all we discussed and got concensus on at the last meeting. Hopefully we can produce a letter from the EAC to the commissioners suggesting against their proposed changes. Even if they don't change their minds, we will have made our position known. If you want, you can use this as summary of our discussion.

Dear Board of Commissioners:

I am writing to you on behalf of the Environmental Advisory Council (EAC) regarding the proposed Economic Relief Package and specifically the proposed changes to the <u>Carroll County Code of Public Laws and Ordinances</u> <u>Chapter 134</u>, and to the <u>Carroll County Landscape Manual</u> addressing the planting of street trees in the land development process. The EAC, in accordance with Carroll County Code of Public Laws and Ordinances Chapter 16- 4,D\* serves as the County's Tree Commission and as such I am forwarding a recommendation that received unanimous support from Council members at our meeting last evening.

While we appreciate the County's desire to encourage business growth by removing onerous development barriers, we believe that by eliminating the street-trees requirement along with the proposal for an earlier return of the bond to the developer for other plantings required will have detrimental results for the County. In addition to the obvious values of landscape beautification and quality of life that trees add to a community, there are other contributions of planned tree plantings that need to be considered such as erosion control, CO2 emission control, shading for cooling neighborhoods/business parks in the summer and wind screens in colder months. The other proposed change to the ordinance that in effect would return the planting bond to the developer immediately after planting is completed, will, we believe, discourage the use of high quality plant stock and decrease survival probability.

The EAC/Tree Commission is recommending a compromise to the proposed elimination of the street-tree planting requirement and proposed changes to the bonding.

<u>Recommendation</u>: Change the required spacing of major street trees to every 50 feet (from current every 40 feet) thereby reducing the number of trees required by 25%; change the required spacing of minor trees to every 25 feet (from current every 20 feet) resulting in 20% fewer trees required. Additionally, we recommend that rather than proposed 100% of the bond being returned to the developer upon completion of planting, that 65% be returned after inspection of the initial planting and 35% returned after one year following inspection and verification of plant survival.

Economic development and sound environmental planning can and must co-exist if we are to be successful in holding on to all the best the County has to offer our current and future residents and employers.

Thank you for your consideration of our recommendation. The EAC/Tree Commission members and I will be available to discuss this with you further if you would like to do so.

Cindy,

I was under the impression after speaking to Cindy (Parr) that they wanted the semi-annual MTBE update, so now I'm confused.

We (the Health Dept.) didn't have anything to do with Finksburg Exxon closing. I assume that was a business decision made by the owners. They were required to submit something in writing to us saying they were closing so we could de-activate their food and water files.

As far as the library is concerned, that issue is bacterial and still on-going. It has yet to be resolved but it appears that it is the result of a malfunctioning ultraviolet disinfection system. The original sample we took from the raw tap did not have bacteria in it. The bacteria only showed up in the sample taken after UV disinfection which typically means it is coming from somewhere w/in the water distribution system and not from the well itself. We have informed Mr. Worth Kerr with Carroll County of this issue and he is working to correct it. I can recite all this tomorrow at the meeting and maybe provide another detail or two if you want. That wouldn't be a problem but as I told Cindy this morning I can't stay past 4 pm tomorrow so I would have to speak before then.

**<u>CALL TO ORDER</u>** - Ms. Sandra Zebal, Chair, officially called the June 14, 2011, meeting to order at 3:00 p.m. asking for approval of the May 10, 2011 minutes.

<u>APPROVAL OF MINUTES</u> – MOTION NO. 130-11: Motion was made by Robyn Gilden, seconded by Dan Andrews, approving the May 10, 2011 minutes. Motion carried.

## COMMUNICATIONS -

1. Chair, Sandy Zebal read a letter sent to the Council from Commissioner Doug Howard, President in response to the letter sent by the Council regarding the Landscape Manual changes. (See attachments) Sandy also commented that the letter sent by the Council was not read at the hearing.

2. Robyn Gilden received an e-mail from Steve Powell stating that he will send the Tree Committee's recommendation on the ordinance change on to staff to put on the Agenda however she has not received any more information.

3. Cindy Parr forwarded the e-mail she received with information regarding a nominee for the open position on the Council. The by-laws state that a person shall not serve more than 2 consecutive terms. Karen Merkle will be finishing her second term July, 2011 and Dan will be finishing his first term July, 2011. Cindy Parr informed the Council that the Commissioners are not bound to re-appoint a member. Karen Merkle is willing to fill the vacant position left by Richard Haddad until someone is appointed.

4. Cindy Parr informed the Council that she is leaving County Government effective August 1. She told the Council that Commissioner President Doug Howard will be attending the July meeting. She does not know who the new liason will be.

5. Dave Pyatt attended a meeting in Mt. Airy that Commissioner Frazier & Shumaker were also attending. In conversation with Commissioner Frazier after the meeting, they were remembering when she was a previous advisor to the EAAB which is now the EAC. Dave voiced a request that the Commissioners all receive an invitation to EAC meetings. Cindy Parr noted that the Agenda is circulated and it is up to the Commissioners to decide if they wish to attend the meeting.

#### **PRESENTATIONS:**

#### Jon Richardson – Carroll County Health Dept.

Mr. Richardson was not present, so Cindy Parr gave information that was received through e-mails with Mr. Richardson. He will be sending a report electronically regarding MTBE's In response to the Council's request for information why the Finksburg Exxon had closed, Mr. Richardson's response was that was the owner's decision. In response to the concern that the Finksburg Library well is contaminated, Cindy Parr read Mr. Richardson's e-mail response. (See attachment)

#### **Donna Davis – Maryland Forestry Board**

Ms. Davis read the State Ordinance Abatement of Nuisance regarding mowing a 50' perimeter around property of more than 1 acre. This applies County wide with properties of less than one acre needing to be mowed to shorter than 12" so as not to be considered a nuisance. The Health Department is the enforcement agency. Donna would like to see the 50' perimeter reduced. She feels that this policy runs counter to the educational efforts of various agencies, such as the Forestry Board, which attempt to encourage landowners to preserve wildlife habitat, promote growth of desirable native grasses and trees as well as reduce emissions by reducing mowing. Cindy Parr said that changes were suggested to the last delegation but no action was taken. The Ag Community was concerned with damage to crops with a 50' border on the property. Dan Andrews mentioned that there are health issues from tall grass such as allergies. Brian Rhoten volunteered that the Tree Commission keep a list of weeds that are a violation.

Chris Spaur noted that unmowed grass in neighborhoods is considered an eye sore and may impact adjacent property values, unmowed grass can pose a safety hazard if it blocks visibility for cars, and that there are listed noxious weeds that would be a concern when present. Otherwise, meadows do not really pose a health threat to adjacent residents. He suggested that the Health Department interpret the county ordinance according to its intent to protect citizen's health and safety, and extend this to include neighborhood aesthetics, but otherwise not enforce the ordinance when a landowner's purpose is to grow a meadow.

#### **OPEN FORUM**

#### <u>OLD BUSINESS</u> –

1. Tree Committee – Brian Rhoten

Brian reported that Jon Bowman, County Forestry Specialist and Gale Engles, Bureau Chief of Resource Management are working on getting grant money for planting Stream Buffers. He informed the Council that the next Tree Commission meeting is July 6 in Room 205 of the County Office Building. The meetings are held the first Wednesday of each month in Room 205 of the County Office Building. Brian also announced that a Forestry Workshop will be held on Friday, October 7 at Carroll Community College. Karen Merkle suggested that developers should be invited to this workshop.

2. Solid Waste Management – Karen Merkle

Karen reported that no meeting was held. A report will be ready for the next meeting.

#### **NEW BUSINESS**-

1. Cindy Parr advised the Council to prepare for Commissioner Howard's visit at next month's meeting. After discussion Robyn came up with a template for each member to use which included –

**CALL TO ORDER** - Ms. Sandra Zebal, Chair, officially called the July 12, 2011, meeting to order at 3:00 p.m. asking for approval of the June 14, 2011 minutes. The approval was postponed until the August meeting because the hard copy Sandy had did not include changes she had e-mailed to the recording secretary.

#### <u>COMMUNICATIONS</u> -

1. Cindy Parr reported in regards to member re-appointments, the information was forwarded to Denise Hoover, Office Associate for the County Commissioners. Mr. Andrews is eligible for re-appointment; there are some questions about term limits for Ms. Merkle. Chairman Sandy Zebal asked when can we expect action on filling the vacant position? Ms. Parr advised her to ask Commissioner Howard during his presentation.

#### **PRESENTATIONS:**

#### 1. Commissioner Doug Howard -

Ms. Zebal welcomed Commissioner Howard. The EAC members then introduced themselves by giving a brief background. Commissioner Howard then presented and distributed a list of Environmental Principles he will be presenting to the Board of County Commissioners on Thursday, (see attachment). Goals expressed by Commissioner Howard are to work with existing organizations. The EAC provides opportunity to explore possibilities. He advised members to use their expertise. Robyn Gilden feels more focus should be on health impacts of multiple populations. Mr. Howard said the environmental principals need to be fundamental in development of the Carroll County Master Plan.

Regarding the Board appointments for positions on the EAC, Commissioner Howard said they are in the final stages of getting those accomplished. Ms. Gilden asked if, other than Dan Andrews, has anyone expressed interest. Mr. Howard's response was he is not sure. Cindy Parr said previous interest from a person a couple of months ago was forwarded to Ms. Hoover.

Ms. Zebal asked how the EAC is to communicate with the Board of Commissioners. In the past, requests have come from the BCC or citizens directly. Mr. Howard continued, when issues

arise, they will communicate directly; they are operating relatively informal. If you receive an issue from citizens or if you notice they are discussing something of interest-contact them. If you expressed an opinion to the previous Commissioners, you should present that information to the new Board. Ms. Zebal said she was concerned about the channel of communication, which was previously thru Cindy Parr. Mr. Howard informed the EAC that Steve Powell schedules the agenda items with each Board member able to put items on the agenda or you can come to one of the commissioners individually. Use your current contact or Steve Powell or a Board member making sure to send the information to all 5 Board members.

Dan Andrews stated that he had previously studied solid waste. Concerning the recycling staff – Maria Myers is the one position we have. That is not enough. He thinks the County needs to take a note in getting 20 plus haulers to divert waste to recycling facilities rather than the landfill. Mr. Howard responded that the Board did not add a tipping fee for recycling.

Mr. Andrews said in 2009 the "Cool County" Agreement Resolution/NACO inventory emissions at County Facilities. The County was going to work on reduction. Mr. Howard said the Commissioners have not discussed this.

Ms. Zebal asked who is overseeing the county's energy use. Mr. Howard answered, The Department of Public Works, Tom Rio is the Director. Ms. Zebal said they should be setting a goal to reduce use.

Mr. Rhoten thanked Mr. Howard for attending and acknowledging the EAC. Ms. Petry told Mr. Howard if you are interested in alternatives to waste to energy, we have a lot of information we could share with you.

Mr. Andrews asked if the revolving loan program administered through the sustainability coordinator is still being offered. This program offers low interest loans, energy construction, upgrades in insulation, solar, wind, etc. Tom Devilbiss answered that the loan program is still in place, the status has been forwarded to Steve Powell. People have received funds; some are in progress.

#### 2. Carolyn Puckett – Weed Warriors Program

Weed Warriors are volunteers trained on invasive weeds and how to remove them. Invasive weeds are thistle and vineweed. They are taking over the native plants on hiking trails at Hashawha. Invasive bugs are the Japanese beetles and stink bugs. Caterpillars can only digest native plants, therefore butterflies and birds are endangered. Staff at the Nature Center is reduced-none are available to get rid of invasive weeds, etc. Montgomery County has taken the lead on this type of training and offered an online training program for our County. Last year training was piloted at Bear Branch. This year training sessions were expanded to Piney Run. There were 71 volunteers trained at no cost to the county. The Forest Conservancy Board runs the Warrior Program. Nature Centers tell volunteers what areas to work in. They open sheds for tools. Students can earn volunteer community service hours.

Mr. Andrews asked if information is posted on any websites beyond Sierra Club. Ms. Puckett said it is listed on a couple of sites. Ms. Gilden mentioned that libraries and schools would be a good resource. Ms. Puckett said schools sent out information regarding volunteer community service hours. Mr. Andrews suggested perhaps County Road Staff should be trained. The weed ordinance has moved to the Department of Public Works and invasive weeds are along County roads. Ms. Gilden clarified that all work done is manual, physically removing weeds. Ms. Puckett stated that the volunteers are not using chemicals at this time because of certification requirements. Ms. Gilden cautioned against using pesticides. Ms. Zebal wondered if this could fit in the schools science curriculum. Mr. Andrews wondered if CCPS has someone in charge of Environmental Studies. Cindy Parr said there is a secondary school science supervisor. Mr. Devilbiss said the Soil Conservation District sponsors the Envirothon. They would be a source. Mr. Rhoten suggested using inmates from the Detention Center. Ms. Zebal suggested mass education with tax bills letting citizens know they should be free of these invasives on your property. She also questioned "Can the work be done in the fall when it is cooler?" Ms. Puckett answered "Try to do the work before the berries are on it." Mr. Andrews suggested putting this information on the County website and link to the EAC page.

### OLD BUSINESS -

1. Tree Committee – Brian Rhoten

Brian had no report because the meeting was cancelled for this month. The next meeting will be August 3, 2011.

#### 2. Solid Waste Management – Dan Andrews

The committee met and has recommendations:

- 1. Each municipality should have a recycling coordinator-County could help initiate/coordinate, paid position, performance based. Mt. Airy received an award for best recycling, reduced waste, saved money. Dave Pyatt suggested inviting Wendi Peters to a future meeting. She spearheads efforts for Mt. Airy. Brian Rhoten said the haulers benefit from giving incentives for recycling, not citizens.
- 2. Dumping coupons encourage dumping-there should be a coupon for a discount for recycling bins.
- 3. EAC should meet with Maria or Chuck Ingram to brainstorm, how to educate, increase pay as you throw, then meet with haulers. Cindy Parr said 23 haulers work in Carroll.
- 4. Pay for recyclables at landfill-incentive for haulers, need to have both handled at landfill.
- 5. Need 1,000 more recycling totes with lids that were purchased with grant money.

#### **NEW BUSINESS**-

Kim Petry reminded the Council that it is time to start planning for the Environmental Awareness Awards. She said she needs donations in order to get the awards during County Government Week in April 2012. Nominations are due March 1<sup>st</sup>, the web form needs to be up and running in October 2011. She would like to revise/update the questions with the EAC's review first. Commissioners will present the awards. Robyn Gilden suggested, if not too difficult, to have a subset of different questions for each category-Students, Agriculture, Business. Brian Rhoten suggested to plant several trees this year and have the Environmental Awareness award on Arbor Day. Then half next year at Arbor Day, so each year has an Arbor Day celebration and every other year the Environmental Awards.

Dan Andrews wanted the EAC to know that styrofoam is now being accepted at the Northern Landfill.

Sandy Zebal would like to find the 2007 Carroll County Government Greenhouse Emissions Gas Emissions Inventory from Neil Ridgely's files and forward to Commissioner Howard with a letter. Cindy Parr advised to distribute by e-mail with reference to today's discussion, then come back at a future time to discuss/update figures. Tom Devilbiss agreed to forward the information to both the Commissioners and to Tom Rio at the Department of Public Works. Ms. Zebal suggested that another inventory then be done and a comparison made to determine whether the county is meeting the reduction goals set forth in the Cool Counties agreement. ### Vision

We believe an economy based on free-market principles produces innovative technologies and solutions that can conserve natural resources and promote environmental quality.

We believe that growing awareness and free enterprise will recognize businesses that are good environmental stewards. Individuals and businesses that provide solutions should reap the rewards for conservation and environmentally sound practices. Market-based solutions to protect the environment can be more effective and implemented with fewer economic side effects than a centrally planned government approach to environmental problems.



- In December 2010, the first loan applications were approved by the bank and funds were beginning to be dispersed.
- The program has had eighteen residents who have started the loan process with the County. Ten of these residents have received County approval of their projects and initiated the loan application process. Of these:
  - · 6 have completed loans, with partial/total funds being released
  - 2 have bank approval but no funds have been released
  - 2 have been denied loans



Dear Secretary Hall:

We would like to thank you for the opportunity to provide comments on the PlanMaryland proposal. It is apparent a significant amount of time and effort has been devoted to this process. We appreciate Maryland Department of Planning (MDP) staff holding meetings to present or answer questions during this review period.

We are providing comments on the proposals and concepts and their perceived impacts to Carroll County. While we recognize that MDP staff already is considering and proposing changes as a result of comments received, our comments are based on our understanding of the proposals as written in the draft document. Below we have provided *general comments* on our key concerns.

- The 12 Visions Included in Article 66B are fairly comprehensive. Additional layers of objectives, criteria, and policies are confusing, cumbersome, and somewhat redundant. If the Designated Places move forward, we suggest <u>eliminating the separate layers</u> and just indicating specific criteria or strategies under each Designated Place or Other Planning Area that should be done to achieve the 12 Visions.
- PlanMaryland very nicely distills the main goals of the plan itself down to three goals. Goals 1 and 2 are similar to the goals that have been in place in Carroll County for over 40 years, as reflected in the County's Master Plan, and can be defined and measured more clearly. Goal 3 is laudable and even desirable. However, the implementation and achievement of a sustainable quality of life is *subjective* and is *defined differently* based on the nature of an area and the people and businesses that are part of that community. Specifying how a particular community should define their quality of life, therefore, should be accomplished through local comprehensive plans.

#### **COMMUNICATIONS** -

1. An e-mail was received from the Weed Warriors thanking us for the support we wished to extend. However they are receiving help from the Recreation & Parks Department.

2. Commissioner Howard sent a letter outlining the Environmental Principles that he proposed to the other Commissioners. He would like comments from the EAC on these principles.

#### **PRESENTATION-**

John Modica, President of First Global Visions gave a talk about what his company does and offered to help update the 2007 Gas Emissions Inventory. Mr. Modica is certified as a Building Performance Auditor. He could assess electrical consumption, not gas and oil. Interns from McDaniel College could collect the data and then use a computer program to compare which building is using the most energy, which is making the most improvement from the 2007 study and which building has the least savings, as well as other comparisons. Mr. Modica offered to create forms that could be filled in by building managers for the survey. Goals could be set to cut energy use by 7-10% per year.

Chris Spaur commented that he is not sure if the current commissioners seem to be interested in greenhouse gas emissions. He feels the emphasis should be on energy savings. The council wanted to find out if there is still a contract with Johnson Controls for an energy contract savings program. Previous county staff, including Scott Moser and Rich Shelton, have been speakers for the EAC. Robyn Gilden asked how long we should expect to wait before we see results from the information collected. Some of the areas to look in for savings are: insulation, light bulbs, computer equipment, HVAC and heating

systems. Kim Petry commented that if the county does not have an Energy Savings Performance Contract, they should have a back-up plan.

Sandra Zebal would like to go before the Commissioners to request this update of information be collected by some volunteer interns. The title of the report needs to be changed to "Energy Audit & Cost Savings." Brian Rhoten suggested they could collect data and compose a report, then collect again and compose another report to compare with the first. He also suggested to name the report "Energy Consumption Analysis". Karen Leatherwood asked when the first data was collected and recorded. Sandra Zebal answered that it was 2007 and would like to get copies of the 2008 and 2009 data to compare.

**MOTION 138-11** was made by Robyn Gilden and seconded by Dave Pyatt to have someone go before the Commissioners to request permission to perform a follow-up Energy Consumption Analysis. Motion carried.

Dave Pyatt asked how far in advance we need to get the briefing paper to the commissioners to be included on their agenda. Brenda Dinne answered 2 <sup>1</sup>/<sub>2</sub> weeks and advised the Council to carbon Steve Powell and John Modica.

#### EAC Solid Waste Subcommittee Plan of Action Revised September 2011 DRAFT

The solid waste subcommittee was formed several years ago to address how recycling could be jump started and be dovetailed with efforts to address shortfalls in available landfill capacity in the County and the need for a Waste to Energy (WTE) joint project with Frederick County. More specifically, the expectation several years ago was that a very aggressive recycling program might eliminate the need for either enhanced transport out of the County or the need for a WTE facility. The long-term problem with landfill capacity is largely unresolved and is currently being re-assessed. There may be additional efforts including the possibility of burning some solid waste at the Lehigh Cement facility at Union Bridge.

#### Challenges of "Quantum Jump" approach in Recycling vs "Evolutionary" improvement

Although Carroll municipalities offer some advantages since they generally have a single trash hauler (two do their own trash hauling), the large bulk of the County residential pickup is from a diverse group of about 23 private contractors with no clearly marked territories and generally no multiple dwelling arrangements. The County has not been successful to date in getting these trash haulers to buy into an enhanced recycling program.

It is worth noting that the Town of Mount Airy (just recognized this year for its efforts) spent over fifteen years getting to the point where it is today. Having a Town Recycling Committee and spokesman specify contract provisions to Key Sanitation, the contractor, was crucial. Soon, at a future EAC Meeting, we should ask Mount Airy Councilman Wendy Peters to give a presentation.

#### Suggested Approach for EAC.

The County has been given reasonably high marks in the past two years for its recycling program and has shown steady improvement, albeit slower than some EAC members would prefer. On the other hand, the evaluation of need for or hauling trash is a very highly politicized decision, and appears to be decided without too much input from the EAC. Thus, recycling goals should be addressed regardless of the WTE decision.

Things recommended we should do (or continuc to do):

- Start to maintain a dialog and relationship with private County-wide trash hauler contractors.
- Contact Municipalities and request they identify a recycling coordinator. Hold meetings with
  the objective of boosting recycling--either via the Maryland Municipal League County Chapter
  or the County "association" of Town Managers.
- · Continue to work with Maria Myers on an outreach basis-this could be a joint effort,
- Continue looking into obtaining large recycling bins.
- Provide input into WTE or long term trash options as they become available.
- Invite Wendy Peters soon to speak at an EAC meeting.

The Commissioners would like the Council to focus on Celebrating America. They do not want environmental stewardship to be lost. He is glad the web page is being updated. He advised Ms. Dinne to get in touch with Roberta Windham to set up a monthly meeting if desired, possibly on Mondays. They have 3 major issues: 1- Waste to Energy, the commissioners are looking for first hand information. It is hard to decipher 2<sup>nd</sup> or third hand information. 2-Septic Bill is coming. In the Legislative Session, this will be a major issue in January with MACO. 3-PLAN Maryland-The governor may sign the plan as is. Counties and Senate need more time to discuss. A Forum was held last Monday. The Forum was not a Global Warming Issue. The Forum can be viewed on Channel 24 and the web in 1 hr. increments. Mr. Howard complimented the Land Use, Planning and Development staff for their knowledge and expertise regarding environmental issues.

Robyn Gilden pointed out that there are intangible benefits as well as monetary ones.

Dave Pyatt asked if the EAC would be involved in the Septic Legislation. He stated that 4% of nitrates are in the bay from septic systems and that septic will be a substantive part of the legislation this session.

Chris Spaur feels the commissioners have not been given accurate science information. Carroll's County's environmental stewardship responsibilities extend to Chesapeake Bay, and require consideration of pollutants leaving the county. He feels that costs of various options that could help the county meet its obligations to improve Bay water quality do warrant scrutiny. While not perfect, the Bay Model itself is very objective and scientific, and the contention that the county needs to reduce pollutant outputs via surface water, groundwater, and air is valid.

b. 2012 Work Plan Topics – Environmental Legislation-Septic Bill (Brenda Dinne will track the legislation), Chesapeake Bay Foundation, and Agriculture. Discussion followed by Brian Rhoten, Karen Leatherwood, Dave Pyatt, and Kim Petry.

#### 9. TREE COMMISSION-

a. Brian Rhoten informed that hybrid chestnut trees are available. Also, an agreement is being worked on to plant at Hashawha and Carroll Community College.

#### 10. <u>SUBCOMMITTEE REPORTS</u>

a. Solid Waste – Dave Pyatt, Karen Leatherwood and Bryan Rhoten are working on recommendations regarding environmental impacts and financial impacts.

#### 11. TOPICS FOR FUTURE DISCUSSION

- b. Jan. 10 meeting Brenda Dinne will speak about the Septic Bill. The first hour of the meeting will be dedicated to speaking with the Commissioners about the Work Plan.

#### 9. <u>COMMITTEE REPORTS –</u>





## Final Report of the Task Force on Sustainable Growth and Wastewater Disposal

December 20, 2011

### Introduction

The phenomenal natural wealth and abundance provided by the Chesapeake Bay has been vastly diminished. Once teeming with oysters, shad, soft shelled clams, grass shrimp, and Atlantic sturgeon, the Bay now experiences annual dead zones and its formerly lush and widespread meadows of seagrass are fewer and far between. Meanwhile, on the land, within the Bay watershed in Maryland, our forests are declining again after a half century of steady regrowth, and our agricultural heritage continues to disappear.

The decline of our natural and rural resources is caused by a variety of reasons, including common development practices that consume large amounts of land for each new home, lack of sufficient control of some sources of pollution, barriers to growth within our historic towns and cities, and disparate levels of sound land use planning. Lastly, new threats from climate change – including sea-level rise, precipitation changes and worsening storms – are beginning to impact our quality of life and natural resources and are expected to worsen over time.

Despite these losses, Marylanders still have much natural heritage to enjoy, both on the land and within our waters. Wise fishery management methods over the last decade have brought back striped bass, increased blue crab harvests, and are giving renewed hope to oyster restoration. New stormwater management requirements and wastewater treatment plant technologies are reducing the impact from development to our streams and rivers. Many thousands of acres of farms, new parks, and natural areas have been conserved. Smart growth and historic preservation efforts have reinvigorated many of our towns and cities and have slowed the loss of our rural landscape.

We're at a crossroads in many respects. The federal government, recognizing the failure of voluntary efforts to fully restore the Chesapeake Bay, initiated a new accountability framework in 2010: now, each Bay State must develop and implement a watershed implementation plan, and must meet 2-year short-term milestones and complete implementation of restoration measures no later than 2025. Within Maryland, after 10 years of smart growth efforts, despite some significant successes, there is widespread recognition that much more needs to be done if we are to significantly stem the loss of our rural resources and reverse the decline of many of our cities and towns. Recent innovative responses, such as

Maryland's Chesapeake Bay Watershed Implementation Plan, BayStat, the Maryland Sustainable Growth Commission, PlanMaryland, and the Task Force on Sustainable Growth and Wastewater Disposal raise hope that we can find and implement measures to sustain our existing wealth and achieve a more plentiful future for our families and children.

The Task Force on Sustainable Growth and Wastewater Disposal was born out of recognition that outdated wastewater technologies – septic systems – are one of the few nitrogen pollutant sources in Maryland that continues to increase and which often supports wasteful land development practices outside of our sewered areas. If left unchecked, such practices could undermine Maryland's Bay restoration, smart growth, and sustainability efforts. Maryland's population continues to grow and is expected to increase by 1 million people by 2035. Implementing protective measures now will ensure that the land use and pollution impact of future Marylanders is minimized, giving us the greatest chance of success in restoring the Chesapeake Bay and protecting our rural landscape.

Governor Martin O'Malley created the Task Force on Sustainable Growth and Wastewater Disposal in April 2011 through Executive Order 01.01.2011.05. The charge of the Task Force was to "recommend regulatory, statutory, or other actions to address the impacts of major developments on septic systems and their effects on nutrient pollution, land preservation, agri-business, and smart growth" to the Governor and the General Assembly.

### Role of the Maryland Sustainable Growth Commission

Recognizing that there is some overlap of the mission of the Maryland Sustainable Growth Commission with the focus of the Task Force, the Executive Order required the Task Force to coordinate with the Maryland Sustainable Growth Commission, including holding at least two joint meetings with the Commission to coordinate on issues of mutual interest. Two joint meetings were held on September 12 and October 25. The Task Force acknowledges the work of the Concentrating Growth Workgroup of the Maryland Sustainable Growth Commission, which has developed recommendations that would limit the land consumption and overall pollution impact of new development in Maryland. ### **Decision-Making Process**

The Task Force met ten times from July 2011 through November 2011. Each workgroup met at least four times. State and local government officials, along with researchers and specialists, presented information to the Task Force, specifically those items listed in Section E of Executive Order 01.01.2011.05. The workgroups met and were first tasked with the following: list the impediments to a consensus on principles contained within HB1107 (2011 legislative session), identify the resources needed to move toward a consensus, and outline the direction and early recommendations achieved. Each workgroup was given a list of topics, which were raised by Task Force members as important issues during its first meeting, to use to frame their discussions. Over the course of several meetings, the workgroups identified areas of consensus and areas without consensus in response to the Task Force Chair's request. The areas of consensus and without consensus, with background information, were summarized in the October 25, 2011 workgroup reports at

http://planning.maryland.gov/PDF/YourPart/septicsTF/20111025/allWGprog ressreports102511.pdf. The workgroup's final recommendations were presented to the Task Force, discussed and voted upon.
