The County Commissioners and EAC members met together to discuss the proposed 2012 Work Plan (see attachment), and to report on 2011 projects and issues. The DRAFT Work Plan was discussed first:

The Energy Use & Cost Savings Project Proposal was discussed with the Commissioners asking various questions. Mr. Roush asked if all energy use is being updated. Ms. Zebal answered, "Just the county buildings. Not vehicle fuel. Not schools. The ENERNOC and JOHNSON CONTROLS contracts will help lower prices." Mr. Rothschild asked if geo-thermal vs. conventional fuels for schools and other facilities had been considered. Mr. Rothschild also said citizens are asking about wind power and other alternative sources of energy. He asked if the EAC would consider making recommendations concerning residential alternative energy. Mr. Howard asked if there is a time frame to finish this study. Mr. John Modica answered that it depends on the availability of the interns from McDaniel College who will be volunteering their time to help with this study. The commissioners concurred with going ahead with this project.

<u>Solid Waste Management</u> was also discussed. Commissioner Howard informed the EAC that a forum is being put together to hear from citizens regarding this topic. The Commissioners want to know where we were at the beginning; where we are now and what changes have come about. Mr. Pyatt pointed out that there are updates to the 2007 findings. The costs are complicated and there are many financial variables. Mr. Roush said Frederick County has a different goal than Carroll. Mr. Rothschild pointed out that the problem is lack of fuel for an incinerator. Single stream recycling has decreased trash. The question is whether to burn, bury or haul. Mr. Howard would like suggestions for speakers for the forum. Ms. Zebal suggested Don West or Dan Andrews. The date has not been decided.

<u>Environmental Legislation</u> will surely include a bill regarding septic. The EAC needs guidance as to what assistance is needed by the Commissioners. (Mr. Roush left the meeting at 3:50). Mr. Rothschild asked if we can gather information regarding nitrates getting into the Bay.

Other topics are welcome.

The Annual Report of EAC activities to the Commissioners discussed by Ms. Zebal included the following topics that were brought to the EAC by citizens and the EAC's resulting actions:

1. January 2011 – The Tree Commission created a proposal to protect Critical Root Zones. This has not been presented to the Commissioners yet, even though Chief of Staff Steve Powell has been contacted. Recycling was discussed with the suggestion of a coupon being given with the

real estate tax bill to be used toward purchasing a recycling tote. March 2011 – Lehigh fuel was discussed. June 2011 – Donna Davis requested Landscape Ordinance changes be made regarding mowing around trees. July 2011 – We had Carolyn Puckett of the Weed Warrior Program educate the Council about noxious weeds. December 2011 – Discussion of Draft Work Plan.

- 2. Environmental Awareness Awards were presented in April by the Commissioners and the EAC. Trees were planted in honor of the winners.
- 3. The Tree Commission discussed changes to the Critical Root Zone Proposal; street tree plantings, and Chestnut Trees potentially to be planted at Hashawha.

The Commissioners adjourned their part of the meeting with the EAC at 4:00.

EAC Purpose

The EAC is dedicated to exploration and promotion of the County's environmental management responsibilities and to providing the Commissioners with educated advice that is in the best interest of the County and the County's residents.

EAC Function

The EAC functions at the direction of the Carroll County Board of Commissioners and, as such, works cooperatively with County environmental staff to research environmental policy issues; to advise the Board of County Commissioners; to foster environmental education; and generally to act in the best interest of County residents by promoting effective environmental protection and management principles. The EAC also serves as the County's Tree Commission.

Work Plan Purpose

As an advisory body to the Board, the EAC provides recommendations to the Board on emerging environmental policy and projects. Projects may be individual, discrete projects of the EAC, supplemental or supportive to staff projects, or recommend measures to mitigate environmental impacts for projects initiated by or supported by the Board.

This work plan outlines the topics, projects, and/or issues where the EAC can assist and advise the Board for the coming calendar year. The EAC will review these topics with the Board in an annual meeting. The Board will approve the topics/projects on which it seeks the EAC's input. The Board may modify the scope of these projects before approving the work plan.

<u>CALL TO ORDER</u> - Ms. Sandra Zebal, Chair, officially called the February 14, 2012 meeting to order at 3:05 p.m. Ms. Zebal asked for approval of the January 10, 2012 minutes. Corrections were made and a vote was taken.

<u>APPROVAL OF MINUTES - MOTION NO. 150-12</u>: Motion was made by Robyn Gilden, seconded by Dave Pyatt, approving the corrected minutes. Motion carried.

ANNOUNCEMENTS FROM CHAIR / COMMUNICATIONS -

- 1. Sandra Zebal received a Thank You card form the Commissioners for having them at the last meeting. They also appreciated the suggestions made for the Solid Waste Forum.
- 2. An e-mail was received by Ms. Zebal from Sykesville Middle School with a nomination for the Environmental Awareness Award.
- 3. Chair Zebal indicated she received an e-mail from Mr. Ely regarding a Lehigh permit application to the U.S. Army Corps of Engineers. She referred him to the Corps of Engineers to ask questions and provide comment.
- 4. Ms. Zebal announced the upcoming public meeting regarding Congoleum's discharge permit.

ANNOUNCEMENTS FROM LIASION -

- 1. Brenda Dinne announced that the Solid Waste Forum would be held on the evening of Tuesday, February 28, 2012 at Carroll Community College. The Commissioners had solicited speaker suggestions, which the EAC identified and forwarded to Commissioner Howard's office.
- 2. Ms. Dinne indicated that only two or three nominations had been received thus far for the Environmental Awareness Awards. Kim Petry said they may need to consider extending the deadline if additional nominations are not received soon. Staff will check with Carroll County Public Schools to see if they were only sending the nomination forms out to staff, or if they would also send it to parents using the AlertNow message system.

<u>PRESENTATION</u> – Composting in Howard County - Evelyn Tomlin (Howard County)

Ms. Tomlin spoke about the curbside recycling program in Howard County. Recycling is currently voluntary in Howard County. She said about 25 percent of the waste is made from food scraps. With food scraps separated, there would be a decrease in trash and an increase in recycling. The County spent \$10,000 to conduct a phone survey before the program began. Sixty-three percent of the residents voiced they would participate, with 24 percent indicated they currently compost.

A mini-pilot program including 34 homes was conducted between August 2010 and January 2011. This was followed by a full-scale pilot of 1,000 homes. The compost was collected weekly, using the same truck that collects yard waste. Yard waste and food scraps can be combined, which actually creates a better compost material (Howard County stops yard waste collection in the third week in January each year). Two-gallon indoor containers and various sizes of outdoor containers were provided. Outreach efforts were included a booklet that included information on how to participate. Postcards were mailed to participants. The County estimated that roughly 3.9 tons of food scrap and yard waste were diverted from the landfill. Many people in the program wanted to see the program continue and to expand countywide. They also like having two containers. The majority wanted their own indoor container, because everyone likes something different. No meats, dairy, or fish were to be composted. The average participation of 76 percent weekly was the set-out rate. Indoor containers were 2 gallons. The 65-gallon containers were deemed too big with the 20-gallon cart being okay. Shredded paper and pizza boxes were acceptable. However, no plastic bags were accepted. When asked what motivators there were, 30 percent of participants were not motivated to participate, while 24.5 percent said they had environmental reasons.

A full-scale program including 5,000 homes began in September 2011 and is ongoing. They are achieving about a 20 percent voluntary participation. Different areas were used for the two pilots. The price is the same to the user to have this service, although it is a little more work for the hauler. The County entered a five-year contract with the hauler, with an annual option to renew. Different-sized containers were considered, but they went with the 35-gallon containers. Containers are bought in bulk to save cost, and they need to be stored until given out. Volunteer participants are given free carts. There is no food scraps facility in Maryland large enough to accept Howard County's food waste, so they are now hauling to a Delaware facility. They are not currently saving money hauling to Delaware rather than landfilling. However, they are looking to site their own facility, which would be more economical. The cost of the full-scale pilot project was \$42,590.90, including 35-gallon carts, delivery, assembly, and \$14,071.64 for outreach. All participants are volunteers, and there is a variety of house styles. They had an 82 percent overall participation rate with the full-scale pilot, resulting in a 25 percent decrease in trash. The staff attended composting school and learned how to measure temperatures. Annual fees range from \$210-\$225 per year for curbside pick-up.

Ms. Tomlin added that education and outreach are important for a program like this to work. Two information mailers were sent out with attached glossy reply cards. A public meeting was held at the local library. Online sign-up is available. They have a separate webpage. Booklets, magnets, and container labels were made. They would also like to make videos and have a plastic bag ban.

Ms. Tomlin said the County would like to expand countywide, but budgets are a concern these days.

a. **Solid Waste**: Mr. Hatkin, Ms. Zebal, and Ms. Leatherwood indicated they planned to attend the Solid Waste Forum on February 28. Josh Hatkin attended the meeting in Taneytown regarding the gasification plant. He provided an update to the EAC members. A front-page article appeared in the Carroll County Times with information from the meeting in Taneytown.

b. Environmental Legislation: Ms. Dinne updated the EAC members on the status of the Septics Bill (Senate Bill 236). The hearing was held in Annapolis on February 14. The County Commissioners have not given direction for the EAC to provide input on the bill. It is very complicated, and staff is reviewing the bill. Due to time constraints at this meeting, Ms. Dinne will instead provide an overview of the bill at the March meeting. Ms. Dinne also reported that House Bill 549 and Senate Bills 240 and 614 are of concern to the County. SB 240 proposes to raise the fee for the Bay Restoration Fund, with those on public water charged according to usage. SB 614 calls for counties to create a stormwater utility and charge a fee. It would also require annual inspections; currently inspections are every 3 years. HB 549 also proposes changes to stormwater inspection requirements and practices.

ANNOUNCEMENTS -

1. A meeting was held regarding Congoleum at the Finksburg Library. Brian Rhoten and Robyn Gilden attended. The discharge limits were not changing. Everyone in the watershed was asked to submit a permit renewal, so MDE could know what was going on in the watershed. Congoleum's permit was not due for renewal until 2015.

2. Planet Carroll activities will be held the week before Earth Day. Chris Spaur reported the activities will be held at Carroll Community College and McDaniel College. Nutrient pollution, Global climate change and Smart Growth will be discussed.

3. Tax Bill Coupon- Karen will check with Maria Myers to see if a coupon can be included with the real estate tax bills to purchase a tote for composting.

MOTION No. 152-12 – APPROVAL OF MINUTES – Motion was made by Robyn Gilden and seconded by Dave Pyatt to approve the February 14, 2012 minutes. Motion carried.

COMMUNICATIONS -

1. Sandra Zebal attended a meeting with Commissioner Howard. A sub-committee for the Solid Waste Task Force was appointed with two members from the EAC included. Other members included Don West of Waste Not Carroll and a Business organization representative from Eldersburg. Sandra Zebal asked if more EAC members could serve. Ms. Dinne said she believes Commissioner Howard may have a certain number of people he wants on the committee. Commissioner Howard will task the group with evaluating and reporting options that are based on success demonstrated elsewhere by an existing project, cost-pros and cons, and the ability to scale the option to the needs of the County. Dave Pyatt commented that the problems are big, and the Commissioners want to get a handle on it. Karen Leatherwood said the Commissioners want to go back to the beginning to find out the information. The best three options should be presented to the Commissioners. Technology in 5 years could be very

different from what is in place now. Mr. Pyatt said the County has one to one and a half years to work on this. The Commissioners know what they don't want to do, but don't have a plan on what they do want to do. Brenda Dinne said Commissioner Howard will give direction at the first meeting. Dave Pyatt and Karen Leatherwood will attend the first meeting. Brenda Dinne will ask Roberta Windham if Josh Hatkin could be added.

STAFF LIAISION –

1. The Work Plan is now on the EAC website. Next month Kurt Deery and Kent Martin from Lehigh will be attending the meeting to provide an informational update. Mr. Phil Hager was introduced to the committee as the new Director of Land Use, Planning, and Development for Carroll County.

PRESENTATION -

1. Brenda Dinne explained Senate Bill 236 also known as the Septics Bill. House Bill 1107, proposed in 2011, would have limited subdivisions to 5 lots, but did not pass. The Septics Task Force subsequently studied the issue from July to November last year and made recommendations to the Governor. At those meetings, it was indicated that the definition of a minor subdivision generally ranges from 5 to 8 lots in Maryland counties. In Carroll County, minors are defined as 3 lots or less; 4 or more lots become a major subdivision. Four tiers are to be established with this bill: Tier 1 – areas of existing sewer service; Tier 2- Designated Growth Areas or Priority Funding Areas; Tier 3- areas not planned for sewer and dominated by large-lot development; and Tier 4- Priority Preservation Areas, Rural Legacy Areas and areas mapped by the State. (Please see attached Presentation information.)

TREE COMMISSION – Arbor Day is April 29 this year and plans are being made to plant trees at Carroll Community College. EAC members feel the Commissioners should be asked to attend this planting.

OLD BUSINESS -

A. Energy Use – Brenda reported that John Modica was temporarily relocated by his employer but was still intending to work on the project. He would be back in April. He is to send progress reports on the first of each month.

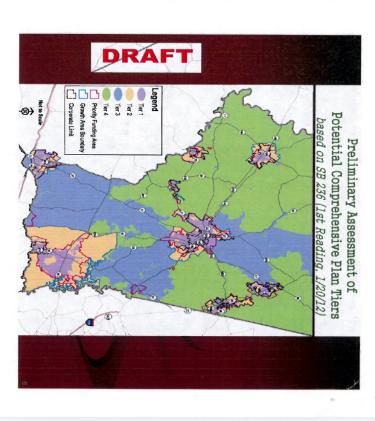

Tier III:

- Areas not planned for sewer; dominated by low-density development; not planned for agriculture or resource preservation / conservation
- Allows minors on septic; allows majors on septic if certain criteria met

Tier IV:

- Areas not planned for sewer; zoned or planned for preservation / conservation OR areas dominated by agriculture or natural resources OR Priority Preservation Areas, Rural Legacy Areas, or areas mapped by ecological or agriculture preservation by the State
- Allows minors on septic; prohibits majors unless zones, as written, achieve actual overall density of <1:25

<u>CALL TO ORDER</u> - Ms. Sandra Zebal, Chair, officially called the April 10, 2012 meeting to order at 3:01 p.m. The March minutes are not available yet for approval, so will be discussed at next month's meeting.

CHAIR & COMMITTEE REPORTS -

a. CHAIR-

Sandra Zebal reported that communication had taken place regarding Lehigh from Dan Ely. She told him no one from the EAC would be attending to represent the EAC since no official role or request has been received from the Commissioners. Ms. Zebal let the EAC members know about the community meeting and invite them to attend if personally interested. Members discussed which agencies had what responsibilities-such as MDE, US Army Corp and the County. Lehigh will be having a meeting on April 18 at the New Windsor Fire Hall. Ms. Gilden felt it would look like more than personal interest if the EAC is in communication with Lehigh, therefore the previously scheduled Lehigh presentation was cancelled. Mr. Hatkin voiced that the EAC has a pretty full plate with the approved work plan, we don't want to spread ourselves too thin. Brenda advised the Council to not feel compelled to address every concern brought to them. They should be referred to the appropriate agency, staff or existing process to address issues if not on the work plan. If there is no existing mechanism, ask for the Board of Commissioners' approval to pursue it. The EAC felt this is appropriate. Ms. Zebal mentioned that the work plan gives the ability to bring additional issues to the Board of Commissioners for approval.

b. ENVIRONMENTAL AWARENESS AWARDS-

Sandra Zebal reported there is a quandary in one category. A school nomination was put in the student category and it was decided to move the nomination to the "institution" category with others because no individual students were mentioned in the nomination. Winners will be announced at the Board of Commissioners time on April 26, when they will be recognized. All nominees will be invited to attend and winners will be announced with those not winning receiving honorable mention.

c. SOLID WASTE SUBCOMMITTEE -

The committee discussed having a coupon put in the tax bills for a discount on a recycling tote. Karen Leatherwood talked to Maria Myers who will look into innovative ways to pay for this idea because it may cost more than anticipated. Another possibility to include in options is to sell rain barrels and compost bins in the future.

d. SOLID WASTE WORK GROUP -

Dave Pyatt reported that the meeting mostly consisted of meeting each other. The group wants to look at the 2007 EAC Solid Waste recommendations first. At the second meeting today the committee

will go through the eleven EAC recommendations and also a presentation from Steve Cassis, who presented to Frederick County several years ago. At the April 20 meeting there will be a Delaware Compost facility speaker. Dave Pyatt said the committee is jumping right in and still needs to go through the state approved system to know how to measure progress. There was no final date to make a decision and it seems the only firm deadline for now is the \$3million investment already made. Ms. Zebal asked if would be good to set a goal of a recommendation by July.

TREE COMMISSION-

The National Arbor Day celebration will take place at 9 a.m. on Friday, April 27, at the grove behind the K Building at Carroll Community College.

ANNOUNCEMENTS FROM LIASION -

Brenda Dinne provided an update on some of the legislation that had been adopted by the General Assembly. If an enrolled bill becomes available on the webpage for the recycling goals bill, Brenda will e-mail it to the EAC.

OLD BUSINESS -

a. Energy Use & Cost Savings Project – No report was received this month from John Modica. Brenda will follow up with him.

TOPICS FOR FUTURE DISCUSSION-

a. The next regular business meeting will be held May 8 at 6:30 p.m. in Room 003.

Natalie Agee of the Venture Crew 202 accepted the award on behalf of Paul Kayzak for Individual category. Jane Castner received an Honorable Mention in the Individual category.

CALL TO ORDER

Ms. Sandra Zebal, Chair, officially called the May 8, 2012, meeting to order at 6:32 p.m. Changes were made to the March minutes.

<u>APPROVAL OF MINUTES – MOTION NO. 155-12:</u> Motion was made by Robyn Gilden and seconded by Kim Petry to approve the March minutes with the changes discussed. Motion carried.

Sandra Zebal suggested changes be made to the April minutes.

<u>APPROVAL OF MINUTES – MOTION NO. 156-12:</u> Motion was made by Josh Hatkin and seconded by Kim Petry to approve the April minutes with the changes. Motion carried.

CHAIR & COMMITTEE REPORTS -

a. CHAIR

Sandra Zebal reported that she attended the Planet Carroll Forum and was very impressed with the information. Parts of the presentation are on YouTube.

b. SOLID WASTE

Josh Hatkin reported on the meeting of the Solid Waste Work Group that was held just prior to the Environmental Advisory Council (EAC) meeting. The Work Group primarily discussed the 2007 EAC recommendations. There was general consensus that not much has changed since the recommendations were made. The Work Group recognized four major ideas from which to move forward:

- Idea #1: Waste is now a resource, not waste.
- Idea #2: Energy independence should be pursued. Most of our waste is going out-of-state. A landfill plan is needed.
- Idea #3: Increased public education is needed on recycling. Education is most effective. Robyn Gilden asked if another person to help Maria Myers was discussed.
- Idea #4: Recycling may need to be mandatory. This may be forced by the State. Curbside recycling is most effective.

Composting was discussed. Food waste needs to be removed from trash. Schools and grocery stores need to get on board with composting; the citizens then will follow. Some schools already do composting. Don West is the Chairman of the Work Group. Dan Andrews is also in the Group. Carrie Knauer from the Carroll County Times reports on the meeting. The next meeting will be held on Tuesday, May 15, at 1:00 at the Carroll County Landfill. The meeting will include a bus tour of the Northern Landfill. Suzanne Hill asked if the tour would be filmed. Brenda Dinne indicated that she did not think the media staff typically filmed events such as tours. Roberta Windham is the representative from the County Commissioners' Office.

TREE COMMISSION

Brenda Dinne commended Brian Rhoten on his presentation and help at the Arbor Day Tree planting at Carroll Community College.

ANNOUNCEMENTS FROM LIASION

Brenda Dinne reported that the Maryland Department of the Environmental (MDE) has released proposed regulations for the use of Best Available Technology (BAT) for new and replacement septic systems. After a public hearing, the Secretary approves the regulations, which could be in effect by summer.

OLD BUSINESS

a. Energy Use & Cost Savings Project

John Modica e-mailed a report to Brenda. He needs to meet with Mike Whitson next. He remains confident in his ability to complete the project by the end of August. The EAC is flexible on the August date of completion. Sandra Zebal suggested contacting Karen Merkle at Carroll Community College for interns. Brenda Dinne recommended waiting to see what the need is to use interns, based on the data available from Johnson Controls, before pursuing interns that may not be needed.

NEW BUSINESS

No new business.

Josh Hatkin remembered that Bruce Holstein is on the Solid Waste Work Group. Mr. Holstein discussed the financial analysis of the Frederick County and Carroll County joint project.

PRESENTATION

a. Update on EPA Audit of County National Pollutant Discharge Elimination System (NPDES) Program (Tom Devilbiss)

Tom Devilbiss updated the EAC on the Carroll County NPDES Permit audit that was performed by the U.S. Environmental Protection Agency (EPA) and MDE on April 26 and 27. This is the first time the audit has been done in Carroll County. When the Clean Water Act was adopted, two permit phases were created. Carroll County is considered a Phase 1 jurisdiction. The eight municipalities in the county are considered Phase 2 jurisdictions. The County holds an individual permit, and we have agreements with the municipalities. The Water Resources Coordination Council (WRCC) handles coordination between the municipalities and the County. The permit is renewable every 5 years and expired in 2010.

Montgomery County was the first county in the state to receive a final permit since the adoption of the Chesapeake Bay Total Maximum Daily Load (TMDL) and is being used as a model permit. Water quality related to all stormwater runoff – drainpipes, retrofits, ditches and swales – are checked. A complete map of storm drain systems, drainage areas, and impervious areas is required. The County is required to identify and monitor systems with illicit discharge within the county and municipalities. Formal pollution plans, implementation of these plans, annual training, and public education programs are all requirements under the permit.

Watershed assessments are expensive. Under the current permit, the County must mitigate 10 percent of 9,000+ impervious acres in the county. MDE is proposing to add another 20 percent to the requirement in the draft permit. The County has already completed many retrofit projects to bring areas, such as Westminster and Eldersburg, up to current stormwater standards. Roughly \$3-4 million each year in capital projects for stormwater retrofits are currently in the capital budget. Through FY18, \$22 million in retrofit projects have been programmed to comply with the permit. Other projects to treat stormwater can also be considered, such as tree plantings. We are currently completing 5-6 projects a year. If certain requirements of the permit are not met, criminal penalties and monetary fines could be imposed.

Two teams were formed. Each team reviewed records and went out in the field to look at retrofits, etc. Mr. Devilbiss handed out the schedule that was followed for the two days. (See attachment). A summary discussion was held at the end of the two days. EPA will issue a report in 3-4 months with findings and fines, etc. Carroll County received praise from the auditors. Mr. Devilbiss said the Program is well supported by the Board of Commissioners.

Chris Spaur asked if the Bureau of Resource Management received additional staff to help with the workload. Tom answered that Glenn Edwards is the NPDES Specialist.

Tom explained that there is an appeals process that gives the County six months to address EPA's concerns/comments. He mentioned that Anne Arundel County had received some hefty fines.

TOPICS FOR FUTURE DISCUSSION

a. The next regular business meeting will be held June 12 at 3:00 p.m. in Room 003. Sandra Zebal brought to the Council's attention that the June meeting will be Dave Pyatt's and Robyn Gilden's last meeting as Council members, as their terms will end and cannot be renewed. There will be two empty positions again. Ms. Dinne indicated that the Commissioners have been notified that vacancies were upcoming and need to be filled.

<u>ADJOURNMENT – MOTION NO. 157-12:</u> Motion made by Kim Petry and seconded by Robyn Gilden to adjourn the May meeting. Motion carried. Meeting adjourned at 7:55.

<u>CALL TO ORDER</u> - Ms. Sandra Zebal, Chair, officially called the August 14, 2012 meeting to order at 3:04 p.m. A quorum was not present to make a motion, so the June minutes were not discussed. This discussion will be held at the September meeting.

PRESENTATION- Mike Fowler, BGE Manager of Local Affairs, and Danny Davis, BGE Supervisor of Forestry Operations gave a presentation on the new Vegetation Management Regulations. The new regulations, called RM43 (for Rule Making) were signed into law on May 10, 2011 to govern how Maryland Utilities manage their reliability efforts. These regulations came about due to the Blackout in 2003. Enhanced tree and vegetation management practices are a large part of the RM 43 regulations. BGE may need to do additional pruning or removal of trees that are located along overhead lines near substations. This is called "blue sky" trimming and includes removal of all overhanging tree branches from substation fence to the first protective device (breaker, transformer, etc.). An annual package of the vegetation management program and schedule will be sent to the Board of Commissioners. The package will also include information about mowing along transmission line corridors. The trimming will be done on a 4-year cycle. BGE will notify customers in advance of the scheduled work with a door hanger that outlines information about the program. Specific details about the work, as well as the name and phone number of the professional licensed sub-contractor will be provided. Westminster is part of the notification to be done. More education to nurseries is a goal of BGE. They have a 10 foot zone rule to stay away from the line when trimming and the line is e-energized while the work is being done. If more than 25% of the crown of the tree is trimmed then the tree will be removed. The web site BGE.com is available with the schedule for 6-8 weeks of work listed. A copy of the presentation and other informational brochures were made available to anyone at the meeting.

CHAIR & COMMITTEE REPORTS -

a. CHAIR-

Sandra Zebal would like each member to be aware of their attendance. She has noticed members are missing meetings quite a bit. Chairperson Sandra and Vice-Chairperson Kim Petry will not be at the September meeting. Karen Leatherwood agreed to chair this meeting.

Sandra reminded members to complete the Open Meeting On-line Training and get completion certificates to Cindy as soon as possible.

Sandra received an e-mail from Rebecca Chase who is in charge of an after school program. Rebecca commended the Council for their website information and links. Ms. Chase requested that a website her group found helpful be added to the EAC web page. That web address is <u>www.heater-home.com/articles-efficient-green-homes</u>. Permission to add this link will be checked on by Cindy and/or Brenda. Kim Petry suggested this group be sent information about the EAC awards for 2013.

ANNOUNCEMENTS FROM LIASION -

a. Tom Devilbiss filled in for Brenda Dinne at this month's meeting. He had a few topics to make the Council aware of. The Economic Relief Package Part 2 is a focus for the Planning Department now. Chapter 134-Landscape Enhancement and Development has some proposed changes. Regarding Tree Screening-a. Exemption - Site re-development plan approval has been added. All adjacent property owners need to give written approval or screening requirements could be waived B. Planting units for screening fence, vegetation or both depends on land use. Jon Bowman, Forest Conservation Specialist from the Bureau of Resource Management came up with reductions in requirements. Planting unit spacing was adjusted: Class A 6.7 to 5 thru Class D. This was discussed at the Planning and Zoning Commission Meeting and they gave their approval.

The Landscape Manual changes include- a. requirements for Communication Towers not to exceed 500 ft. from the right of way.

- b. Floodplain Maps have been updated. The last update was done in 2005. The appeals time is now. This 90 day period ends in mid-October.  A conference call was held on July 10, with Sandy, Brenda and John Modica. The project should be finished by the end of the year.

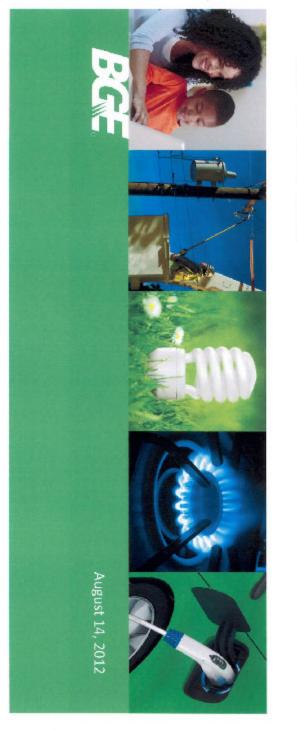

Chris Spaur suggested adding the recommendation for a Recycling Task Force.

The Work Group felt the incinerator in Frederick County is not a good choice. Frederick County is looking at a smaller-scale incinerator. Carroll County is still liable for our part with the incinerator unless another county replaces Carroll.

The Work Group recommends looking at the current landfill location to identify ways to extend the life of the landfill by reducing the waste stream and possibly expanding its capabilities. The value of the land is very important. Maintenance cost associated with the landfill is also a factor to consider.

c. TREE COMMISSION – Nothing to report.

ANNOUNCEMENTS FROM LIASION -

a. Brenda Dinne suggested the EAC may need to find another meeting room to hold evening meetings, since the Commissioners have now scheduled Room 003 for the second Tuesday evening of each month, or choose a different day for evening meetings if the EAC chooses to continue to hold evening meetings.

b. The proposed 2013 meeting dates will be discussed at the November 2012 meeting.

c. Potential projects to include in the EAC's proposed 2013 Work Plan will be on the November 13 agenda.

d. Brenda would like topic suggestions for future meetings.

NEW BUSINESS-

a. FEMA FLOOD INSURANCE RATE MAPS UPDATE – JASON STICK

The most recent topography maps are 35 years old. The 100-year plan was last printed in 1978. Letters were mailed to approximately 3,000 property owners in July. Mr. Stick has received about 350 phone calls with only about 5-6 actually in a floodplain. NOAA (National Oceanic and Atmospheric Administration, National Weather Service) defines a flood as a period of eight inches of rain in a one-hour time frame. Land use, condition of the land, and base flood elevation are used to determine if land is in a floodplain.

A meeting was held on August 23 at Carroll Community College to look up properties and answer questions property owners had. The County is in charge of enforcing regulations with Maryland Department of the Environment and FEMA (Federal Emergency Management Administration). A 90-day appeal period ends on October 15. There are 180 houses in the 100-year floodplain.

Carroll County adopted the Floodplain code in 2004. A building permit application must be reviewed for floodplain issues before approval of the permit is given.

b. MONOCACY STREAM NAMING CONTEST – BARBARA KEARNEY

Three streams in Frederick County and three in Carroll County are in the naming contest. The three in Carroll County are 1) between MD Route 140 and Frederick County; 2) west of Westminster, south of Springdale Road at Hyde's Quarry; and 3) between Union Bridge and New Windsor at Hoff Road.

The contest is open to all with the deadline being December 31, 2012. The website is <u>www.themonocacystartshere.org</u>. Another stream that was named by a similar contest is Longwell Run, which was named by a group of middle school students.

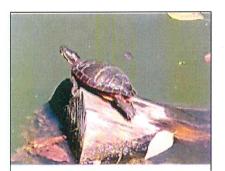

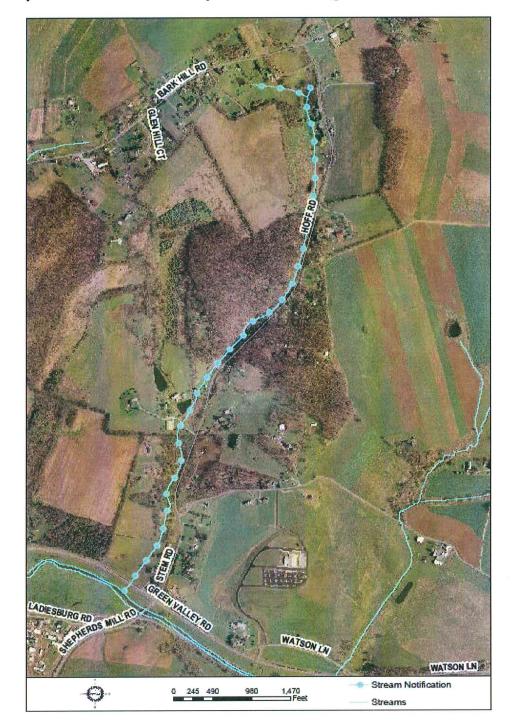
Carroll County Stream # 1 – Vicinity of Starner's Dam & Bridgeport

Stream number 1 is located approximately 2 miles northwest of the City of Taneytown and empties into the Monocacy River approximately 0.6 of a mile south of the rural village of Starner's Dam. It flows westerly for slightly over 1 mile through a mostly wooded valley between Baptist Road and Bullfrog Road. It crosses McMullen Road 0.4 of a mile south of Baptist Road and about 0.5 of a mile north of Bullfrog Road.



Carroll County Stream # 2 – Vicinity of Jasontown & Hydes Quarry

Stream number 2 is located approximately 1.4 miles west of the City of Westminster (along Bell Road) and roughly 1.3 miles north of the eastern limits of the Town of New Windsor. It follows a wooded valley south of Springdale Road heading westerly towards Jasontown Road, which it crosses .3 of a mile south of Springdale Road. It parallels Jasontown Road for just over half a mile, including its crossing of Smith Road as it bisects wetlands and reforestation buffer areas. It veers away from Jasontown Road at the entrance to Hydes Quarry, which roughly one quarter mile west of the three-way intersection of John Hyde, Ruth Shriver and Roops Mill Roads. From the entrance to Hydes Quarry, stream number 2 runs just over 700 feet before emptying into Little Pipe Creek.



Carroll County Stream # 3 – Vicinity of Union Bridge, Bark Hill & Linwood

Stream number 3 is located less than a mile east of corporate limits of the Town of Union Bridge. It originates in the southern reaches of the village of Bark Hill and flows for just over 1.5 miles before it ends at Little Pipe Creek. It first appears in a field about 350 feet south of Bark Hill Road and roughly 800 feet west from the intersection of Bark Hill and Hoff Roads. Hoff Road parallels the stream's upper reaches through both open fields and wooded areas before intersecting Stem Road. Its last 1,100 feet veers to the west, away from Stem Road. The end point is confined by a pipe about 400 feet west of the intersection of Stem Road, Green Valley Road (MD 75) and Shepherds Mill Road just west of the historic village of Linwood. The stream outfall empties directly to Little Pipe Creek.
