4. Shelter Services - Jenny Graybill and Samantha Brong

- **a.** Night by Night 46 total served; 82% utilization rate; summer slow down to 20-23 per night; more folks choosing to stay in encampments during summer months
- **b.** Adult Only 30 served; 99% utilization rate; 18 people on our Adult Only needs based list
- **c.** Family Shelter 7 households served; 106% utilization rate; 6 families on our needs-based eligibility list; 100% exited to perm housing with as VASH voucher
- **d.** Health Department doing an Owning Your Choices class in mid-August for NbN and AO participants early in morning, breakfast served
- **e.** The process of transitioning the Family Shelter to The Cove looking for people with lived homelessness experience to help and plan the design of the new Family Shelter

- c. Staying at complete capacity; starting to hotel some folks and doubling up rooms
