## 2023 Advanced Life Support Recertification and Skills Session Dates

Carroll County Department of Fire and EMS will be hosting the 2023 ALS recertification at Carroll Community College this year on January 28, 2023, January 29, 2023, and February 11, 2023. All ALS clinicians that need recertification are urged to attend. Attendance at all three dates will be required for successful completion on the ALS recertification. Attached is a copy of the schedule for the recertification. This will be the only class offered by Carroll County Fire and EMS for this recertification cycle.

ALL ALS clinicians regardless of expiration date, will need to complete a skills evaluation course prior to July 1, 2023. During these skills sessions we will cover some new devices such as Igels, CPAP, and Pelvic Binders. In addition, review of ALS skills will be completed.
