#### **EXECUTIVE SUMMARY:**

The Office of Procurement in cooperation with the Carroll County Workforce Development Office, requests your approval to award contracts to Transfr, Inc, in the total amount of \$109,375.00. Two contracts will be awarded, the first contract is for ARPA 2 (\$54,687.50) and the second contract for Blueprint (\$54,687.50). Each contract has three (3) one-year options for renewal. Pricing is per an Equalis Group (cooperative purchasing organization) contract #R10-1157B.

Transfr, Inc. will provide classroom-to-careers pathways, training workers for well-paying jobs across every industry via hands-on, simulated training that teaches critical skills for in-demand jobs.

Funding has been approved in the FY24 budget.

#### **BACKGROUND:**

Since the pandemic, occupational training has transformed beyond the traditional classroom-style delivery. CCWD has seen the growth of online trainings which appeals to students and businesses alike. On-demand training is trending with employers as a time-effect tool to upskill employees. Virtual reality is the newest occupational training available which combines on-demand availability with hands-on learning. The Transfr platform offers career exploration and occupational training in the following areas: automotive, health services, electrical, construction, manufacturing, hospitality, and tourism. These trainings align with local in-demand industries. This hands-on training appeals to all age jobseekers. It has been used successfully in other state workforce systems and is now expanding into Maryland. CCWD looks forward to utilizing this training opportunity to develop the work skills of our citizens.

Transfr will be utilized under two grants: ARPA will utilize this learning platform for out-of-school youth and adult jobseekers. Blueprint navigators will assist HS junior and seniors who have not met the Blueprint measures of College and Career readiness to explore and identify potential career pathways.

#### Citizen Services Briefing Paper 3/14/2024 Open Session

**Issue**: Request for Public Hearing – Local Ordinance Creation - Establishing eligible uses for the Community Reinvestment and Repair Fund (CRRF)

#### **Background:**

The Maryland Cannabis Reform Act legalized adult-use cannabis on July 1, 2023. A percentage of adult-use cannabis tax revenue will be granted to each jurisdiction through the Community Reinvestment and Repair Fund. Carroll County's initial quarterly payment of \$84,618 has been received.

The fund must support community-based initiatives that benefit low-income communities and/or communities that have been disproportionately impacted by the enforcement of cannabis laws. Suggested uses of the fund include:

- o Mental Health and Harm Reduction
- Education and afterschool programs
- o Housing and Unhoused prevention services
- Reentry and Reintegration
- Adult Professional Development
- o Entrepreneurship and Economic Development
- Nonprofit training and management to support BIPOC community leaders
- Workforce development and training

Local governments are not held to these uses, but the fund cannot be used for law enforcement or to replace local government funding of current programs.

The governing structure and use of the CRRF allocation rests with the county, and each county must adopt a law establishing how funds received from the CRRF may be used.

The purpose of the proposed public hearing is to gather community input on the use of the Community Reinvestment and Repair Fund (CRRF) in Carroll County.

## Department of Public Works Carroll Transit System Briefing Paper March 14, 2024 Open Session

**Background:** Carroll Transit System provided over 100,000 passenger trips in FY23 to older adults, persons with disabilities, and the general public through demand response (door-to-door) service and the TrailBlazer (deviated-fixed routes). Over 55,000 trips have been provided to date in FY24 with a fleet of 40 vehicles.

Public transportation is funded in Carroll with a mix of grant funding from the Federal Transit Administration (FTA) and Maryland Transit Administration (MTA), fare revenue collected by the vendor, and County funding.

Election Law §8-102(a)(1) requires the Carroll County Board of Elections to send notice of each election in its county to the registered voters of the county by mailing a specimen ballot at least 1 week before the first day of any early voting period before the election. The specimen ballot includes pertinent information about the election such as the voter's polling place, the county's early voting centers, the time and days of early voting and election day, and a sample ballot that the voter will see if they vote in-person. Specimen ballots are not mailed to voters who have requested a mailin ballot.
