Important Information: A Notice of Appeal or Application for Hearing must be filed with the Office of Administrative Hearings in the County Office Building. The staff may assist in completing the forms; however, it is the **Appellant’s** or **Applicant’s** responsibility to complete the forms, including the names of the owners of surrounding properties, their mailing addresses, parcel numbers, and information requested for the plot plan. Incomplete applications are not acceptable. Cases are scheduled based on receipt, completeness, estimated time considered necessary for the hearing, and attorneys schedules. Receipt of an appeal or application on a filing date noted above does not guarantee scheduling for the next hearings. The Board, in accordance with the state Open Meetings Act, renders an oral decision after deliberations, and a written decision is issued within 30 days, unless the Board extends the time. **The decision is not effective until the written decision is issued.** More time may be required for decisions in contested or lengthy cases.

Filing deadline is the second Friday of each month.

Agenda is prepared by approximately the third or fourth Friday of each month.

Normal practice is to publish a notice the last Monday of the current month or the first Monday of the following month before the next month’s scheduled hearing, depending on how late in the following month the hearings are scheduled.
