6. Upcoming COC NOFO Application Update - Carly and Debby

- Funding is changing and will be competitive
- Teir 1 30% of funding
- Tier 2 70% of funding (competitive)
- HUD is encouraging transitional housing
- Focused on ending street homelessness, improving outcomes and minimizing trauma
- Ony 30% funding tied to perm supportive housing
- Ability for extra points for 30% in services for substance use
- Looking to have on site treatment options, 24/7 access to detox, 40 hours of treatment/week

- 25% match for all services; match can be in-kind as long as its documented
- December 12 project applications are due

7. Habitat Project – Jenny Graybill

- Habitat for Humanity is building 25-30 houses behind the Health Department
- Moving forward slowly
- Survey company is marking up the site (survey)
- Breaking ground tentatively in 2027-2028
- Geo map of area and plotted out where the encampments are
- Need to have a plan for exit strategy of 13 individuals
- Will have short term and long-term housing options and will allow pets
- Provide a joint letter from the County and the Health Department for the encampments
