5. Outreach Update – Mike Clavin

a. Resource Fair – went well; 32 vendors; handed out 135 cards to participants; free haircuts and breakfast served

6. Shelter Services - Jenny Graybill and Samantha Brong

- **a.** Night by Night 64 total served; 97% utilization rate; perm housing 4/24, 17% exited to perm housing; 1 went to Rapid rehousing, 1 to family, 2 to friends of family, 7 went to adult only shelter, and 1 to a substance abuse facility
- **b.** Adult Only 35 served; 94% utilization rate; perm housing had 100%; 1 exited with a VASH voucher; 4 to rapid rehousing
- c. Needs based list night by night never a needs-based list; adult only has 12 people on the list; family shelter has 7 on the list
- **d.** Family Shelter 8 households served; 11 adults and 18 children; 100% utilization rate; 100% exited to perm housing with as VASH voucher
- e. Street Outreach 19 people served with no one exiting the program

9. Health Department Update -Amy Baker

- a. Hiring for peer support specialists
- **b.** Nope to Dope Walk on May 20th 10am-12noon at Westminster City Park; 11am is Softball game law enforcement vs recovery community
- **c.** Annual First Responder Appreciation Luncheon on May 24th looking for people from the recovery community to deliver lunches to first responders

- a. Youth Homelessness Subcommittee meeting on pause until July
- b. Youth Action Board met with Zion and Sarah and looking forward to continuing to engage and support them
 - 1. Still have funds available for stipends and food for meetings and trainings

- 2. YAB executive team does receive hourly compensation for the work that they put in to the YAB
- **c.** Youth Homelessness Demonstration Project still looking to apply and due June 27th; must submit their own video; Billy Lyve helping create a video to submit for grant
- d. CCPS Youth Services shared information on Homeless students to-date this year 2022-2023
 - 1. As of May 30, 2023 (146) students have been identified as homeless, up 18 students from last month. This is a cumulative/running report with the exception, if a student has withdrawn from CCPS (i.e., home schooling, private school, moved out of county, etc.), they have been removed from the chart.
 - 2. American Rescue Plan expires on September 30th; received extension to go through September 2024; funds to help youth with:
 - Tutoring
 - Counselling
 - Clothing and personal supplies
 - School supplies
 - School based fees and registrations
 - Community based fees and registrations
 - Emergent hotels
