- 1. Welcome and Announcements from Board Members
 - Welcome and introduction of Ed Singer as the new Local Management Board Manager
 - Gina Valentine Seniors on the Go Expo, September 13, 9am-2pm at the Shipley Arena
- 2. Approval of July 24th Meeting Minutes
 - Past Meeting Minutes will be posted online
 - Tammy Black motions to approve with Celene correction; seconded by Scott Yard; July 24th minutes approved with no objections
- 3. Shelter Utilization Jenny Graybill
 - Night by Night 40 individuals which is high for the summer season
 - Adult only has seen a reduced capacity
 - Homeless per fiscal year that were outside of Carroll County:
 - i. FY 22 23%
 - ii. FY23 25%
 - iii. FY19 16% prior to the pandemic
 - For July and August Night by Night saw 99 individuals; 1/3 of those were brand new to homelessness; 36 new people and 18 from outside Carroll County; 5 come from outside the State of Maryland; 4 were discharged from Carroll County Hospital; and an additional 4 from recovery homes
 - Discussion on how to limit outside counties sending their homeless to Carroll County
 - Tammy Black Access Carroll received 18 patients who are 100% medical respite candidates; 75% of those were sent to the Shelter
 - Interest in having Brian Henline attend these meetings
 - Vicky Kretzer has worked in Washington and Frederick counties and has experienced the same things that are happening in Carroll County; possible idea to come up with structure for intake to emphasize Carroll County residents
 - Celene Steckel to reach out to Michael Robinson to find out what is the process for rerouting patients, giving them a choice for hospitals
 - Amy Baker suggested changing the messaging on HSP website
 - Scott Yard interested in knowing and understanding how they decide where to send discharged patients
- 4. DHCD Shelter Assessment and Performance Improvement Timeline Celene Steckel
 - Circle of Caring needs to conduct assessment using their tool looking at how we are doing Housing First
 - Cheryl Gosaguio and Melissa Zahn along with Dr. Olszyk COO of Carroll Hospital may sit in on Executive COC meetings
 - Shared PowerPoint
 - i. Complete performance assessment of shelter with pros and cons
 - ii. Bed inventory
 - iii. HMIS participation
 - iv. Timeline is to return by then end of October
 - v. Developing a subcommittee and will have the first meeting next week following the DHCD call in September

- vii. Debby Standiford it's a reallocation of funds; will lose some shelter money; bonus money for diversion received half YTD; other diversion funding to come after completion of the assessment
- 5. Performance Measure Discussion Corey Hardinger
 - Shared handout Race Equity FY23 COC
 - Diversion Jenny Graybill
 - i. 1,340 on HSP screening line which represents 603 households
 - ii. 737 security deposits/eviction preventions
 - 276 helped with security deposits
 - 489 were eviction preventions
 - 52% of funding came from ERAP
 - iii. Out of the 603 households
 - 220 hit coordinated entry
 - 123 then went into shelter
 - Data Committee meeting starting next month
 - Homelessness with Lived Experience
 - i. Dennis McConnville writing a letter of support; also working with design and engineering firm for the new family shelter
 - ii. Pulling some of Youth Action Board work to help
 - iii. Surveys from housing at shelter
 - iv. Perm supportive housing data
 - Everyone stayed in place with new lease or leased up with HUD
- 6. Strategic Planning COC Half Day Retreat Celene Steckel
 - At the Arc on October 23rd from 12:30-4:00pm
 - Boxed lunches will be provided
- 7. COC NOFO Updates Corey Hardinger
 - Good progress on application; everyone is submitting their pieces
 - Debby Standiford doing project ranking
 - Corey and Jenny are tackling Performance Measures
 - Submitting for bonus projects, HSP and DV for RRH support for victims
 - Will be sending out to Exec COC for formal approval of written standards
- 8. Subcommittee Updates
 - Data Committee meeting on September 6th and will be continuing quarterly in the Bollinger Room at Citizen Services
 - Youth Updates Youth Homelessness Subcommittee combining with Youth Council sometime in September on 3rd Wednesday perhaps; no Youth Homelessness Demonstration Project award confirmation yet
 - Coordinated Entry Subcommittee reconvening with Kaysy and Cristina; adjusted policies and procedures and will send out to the Exec COC

- Ending Veterans Homelessness Subcommittee meet monthly or bi-monthly and provide updates on placements; have great collaboration with HSP and CCHD
- Affordable Housing Planning Subcommittee process is moving forward with selecting a vendor; request for proposal has gone out
- Outreach Resource Fair October 4th with Rain date of October 11th, 10am-1pm at Ascension Church; 2 pop ups are planned for the Fall, November /December United Way and November in Hampstead with NESAP
- Amy Baker said the CCHD RV "Health on Wheels" will be at the October 4th Resource Fair; still 2 persons in an encampment behind the health department
