These items will be distributed to veterans in need. In November, the program referred 22 veterans to Babylon Vault for a Thanksgiving meal. One veteran received rental assistance, and another received assistance with vehicle-related expenses. One veteran was referred to HUD-VASH for an assistance screening.

National Guard members and Reservists with 20 years of qualifying service, who are entitled to retired pay or who served the full period of service after being called to active duty Spouses, minor children and adult dependent children.
